Central Elementary Items for the Good October 2018

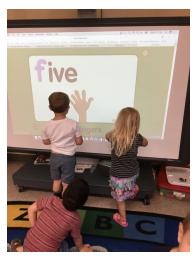
#### Preschool

Preschool has had a busy month! Some highlights include: exploring ramps and tunnels, creating a car wash, technology, and painting! We learned that the angle of the ramp has a direct impact on the distance a vehicle travels! We took our vehicles through a bubble car wash after they raced. Students also used marble track to create various paths for marbles to travel! Trial and error helped them build a successful marble track in which the marble made it from the top to the bottom without getting stuck! We introduced the Promethean board and they really enjoyed using this technology! We learned how to build "Mat Mat" to teach students how to draw the parts of a person. We found "magic" letters while learning how to use watercolors!







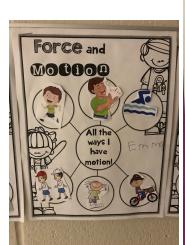






# **Kindergarten**

We have had another fun month of Kindergarten! We explored forces and motion through several hands-on activities and experiments. We have also been learning about the weather. We are documenting weather to notice patterns and to understand how weather changes over time.









# **First Grade**

# **Second Grade**

The second graders have been learning about the structure and properties of matter. They have been exploring and discussing properties of solids, liquids, and gases and how they are visible in everyday life. They have discussed the relationship between matter and our five senses. In class, the students have conducted investigations to describe and classify materials by their observable properties, such as color, flexibility, shape, and texture. Our students have also explored and gathered evidence to prove that heating and cooling can cause some physical changes that are reversible and some that are irreversible.

We're off to a great start in the library this year! Students have been learning about book care, how the library is organized and how we use the author's last name to organize the fiction section. # Reading

At the beginning of this year, teachers at Central participated in LETRS (Language Essentials for Teachers of Reading and Spelling) training. This was the fourth module proceeded by the first three modules presented during the spring semester last year. LETRS, which was developed by Louisa C. Moats, addresses the areas of reading, writing, and spelling. The modules provide resources to help understand how children learn and why some children are challenged with the tasks of reading. Phonemic awareness and phonics skills are included as well as how all components of reading instruction are related.

The training presented in August emphasized the importance of word meanings for reading comprehension and reviewed research-based approaches to vocabulary instruction. The roles of home language, reading aloud, verbal modeling in the classroom, and independent reading in vocabulary development were shared. Methods for teaching the importance of word knowledge were introduced and practiced.

LETRS is not a reading instruction program. It complements and supports programs developed by reading research. Students' challenges with reading and writing can be addressed if the structures and functions of language are taught to them directly. Teachers at Central are excited to be learning about LETRS and implementing these ideas to support reading.

# Freedom March

In September, students at Central Elementary participated in Celebrate Freedom Week.

Throughout the week, students learned about the Constitution, the United States flag, and the

Pledge of Allegiance. As an activity for Constitution Day, the entire school had our own Freedom March that started in the gym for an assembly where we sang songs and and said the Pledge of Allegiance together.

#### School-Based Mental Health Services Provided at West and Central by PMHC

We are so excited to be able to offer School Based Mental Health Services to our students in a partnership with Pawnee Mental Health Center of Manhattan. This year, we will have a Licensed Master Level Social Worker, Madison Book, available to see patients at school at both Central and West Elementary Schools. Miss Book is at Central all day on Wednesday and at West all day on Thursday. Her hours can/will expand based on need. Please see the introduction below from Madison.

"Hello! My name is Madison Book and I'm a licensed master level social worker at Pawnee Mental Health Services. I am new to both the Central and West Elementary teams for the 2018-2019 school year as a school

based mental health therapist. I provide therapy services in the school on Wednesdays and Thursdays. I will primarily work with those children who would benefit from mental health services, but who have difficulty getting to an office appointment during the school day.

If you have any questions, or would like to set up therapy for your child, please reach out to me at (785) 587-4310, your child's teacher, or the school principal. Thank you for welcoming me to your USD 320 family."

A couple of important points to make regarding School Based Mental Health Services - You must become a patient of Pawnee Mental Health Services in order to participate in this program. When you contact Madison, she will get the intake process set-up so that your child can see her at school instead of having to make appointments outside of school for therapy. Also, all therapy appointments at school are confidential and treated carefully. Miss Book will have a space in our office to provide services and the privacy of all students receiving services will be protected.

# Second Step Updates for August 27 – October 1, 2018

As we continue to implement our Second Step Social Emotional Learning Curriculum, we want to keep parents and BOE members updated on the content we teach at West. Below are updates shared with families for August 27 – October 1, 2018.

During the first Second Step lesson for third grade the week of **August 27**, students learned the importance of listening and focusing attention on **Being Respectful Learners**.

With lesson 2 during the week of *September 4*, they continued with *skills for learning*, as they discussed the topic *Using Self-Talk*. The students learned the importance of using self-talk to help them stay on task and ignore distractions. Self-talk will also help them make better decisions in stressful situations.

For the fourth and fifth graders, the Second Step lessons began on *August 27* with the topics of *Empathy and Respect*. Empathy and communication skills have been shown to increase school success and decrease problem behaviors. Empathy and respect are crucial for developing healthy communication and interpersonal relationships. Empathy and respect will be taught throughout the curriculum.

Listening with Attention was the lesson for fourth and fifth graders during Lesson 2 the week of September 4. Students were able to identify and practice techniques that will improve their ability to focus and listen well. The students practiced good listening using SLANT. SLANT stands for Sit up straight, Listen and learn, Ask and answer questions, Nod your head, and Track the speaker. The skill of listening is necessary for effective communication and academic success.

During the week of **September 10**, all students learned about **Assertiveness** during our Second Step lessons. In our lessons, we identified passive, aggressive, and assertive responses. Assertive response guidelines are to keep our head up, use a firm, calm voice, and use respectful words to state what we want or need. The students then practiced how to respond assertively in response to scenarios with a partner.

During the week of **September 17**, third grade students learned about **Planning for Learning** during their Second Step lessons. They practiced writing a three-step plan and then checked their plan to see if it was in order, simple, and something they could do.

The fourth grade lesson was about *Respecting Similarities and Differences*. Students identified their personal feelings to a list of scenarios. They then worked in a group to compare their feelings and find similarities and differences. They identified that respecting similarities and differences helps us show empathy.

Fifth grade students learned about and practiced *Predicting Feelings*. They worked with a partner and made predictions on how their partner might feel in response to scenarios. They then compared how accurate they were. Students identified how predicting feelings helps us be respectful and show empathy.

Our lessons during the week of *September 24* were about feelings. Third grade students learned and practiced *Identifying Others' Feelings*. The students practiced recognizing the feelings of others as well as labeling our own feelings. We then identified if our feelings in a given scenario were the same or different from our partner's feelings.

The fourth grade lesson was *Understanding Complex Feelings*. We identified multiple feelings in various scenarios and named possible reasons for those varied feelings. Understanding complex feelings helps us show empathy for others, which is an important Second Step and life skill.

During fifth grade lessons, students learned about the importance of *Taking Others' Perspectives*. The students demonstrated the ability to take someone else's perspective in a given scenario. We then discussed how taking the perspective of another helps us show empathy, a skill we continuously work on in Second Step.

October is National Bullying Prevention Awareness month, and the students at West will be learning about bullying and ways to help our school be a safe and respectful place for everyone. During this month, their Second Step lessons will focus on four important topics, Recognizing Bullying, Reporting Bullying, Refusing Bullying, and what it means to be a Bystander.

Our Bullying Prevention Unit for Second Step will begin with our Bullying Prevention Kickoff on *Friday, October* 5 with our *Bullying Prevention Unit* lessons taking place the rest of the month. *Kansas Bullying Prevention week is October 8-14*.

#### Anti-Bullying Awareness Week Activities at West Elementary

We had our kick-off for Anti-Bullying Awareness Week, which is October 8-14, 2018, on Friday, October 5 in the West Gym. We began by giving an overview of the lessons students would be engaged in this month during their Second Step lessons, then watched a short video clip about bullying prevention, followed by the West Rules Against Bullying, and our Consequence Matrix if/when students engage in bullying behavior. We ended with a song that we play each year called "Stand Up", by Mike Tompkins. Thank you to Counselor, Robin Butler, for organizing our Kick-Off and for assisting with the presentation with Mrs. Flinn.

We will be teaching our students about anti-bullying efforts the entire month of October through our Second Step Curriculum. Students will learn how to recognize bullying, how to report bullying, how to refuse bullying, and the role of the bystander.

To increase awareness, we are also hosting a "Spirit Week" October 8-11. The activities will be as follows:

During the club sessions, the students explored possible STEM careers including chemistry, engineering, coding, design, agriculture and more. Mr. Schneider is the author of <u>Silver Shoes</u>, <u>The Powder of Life</u>, and <u>The Magic Belt</u>, three highly regarded contemporary Oz novels for students and young adults. Mr. Schneider had the good fortune of meeting and being a pen pal of Margaret Hamilton, better known as the "Wicked Witch of the West" in the original "Wizard of Oz" movie. He was born in New York City and raised in Lawrence, Kansas. At various times, he has been an actor, writer, composer, singer, and arranger.

Mr. Schneider offered a discounted price on his books to our students this year - \$5 off the regular price. Quite a few students took this opportunity to purchase one or more of his books to read.

Third grade students heard a presentation by Jane Albright, current president of The International Wizard of Oz Club, ozclub.org. She discovered the Oz books as a child. Later, her Oz books and memorabilia won a Kansas University book-collecting contest in 1977, resulting in a public exhibit that shifted her interest from reading and collecting to sharing Oz with others. This presentation was also on Thursday, October 4.

We want to thank the Oz Museum and Claudia McAlister, Oz Board Member and volunteer, for organizing this opportunity for our students! We enjoyed hosting these guests!





#### • West Implements Student Council

West Elementary had their first Student Council meeting on September 17! This new student group's mission is to provide students an opportunity to represent West Elementary as leaders in school and community-wide projects. Students are committed to lead by example, demonstrate respect and responsibility, and engage in service. All members help with monthly newscasts, kindness projects, creation of a spirt week, school climate, and morning announcements. Students were selected by a panel of West educators who reviewed applications and letters of recommendation. A total of 8 students per grade level were selected for a Student Council of 24 students for West. Thank you to Third Grade Teacher, Haylee Haynes, for creating this opportunity for our students. Mrs. Haynes has created this project as part of her Master's Degree requirements in Educational Leadership through Fort Hays State University.





#### West Fall Carnival a Huge Success!

Our total profit for the West Fall Carnival was \$7,133.30! This is great! It is lower than previous years, but I think that was due in part to the weather and moving all activities indoors. We are still very pleased with this profit and know that these funds will continue to benefit the students and staff of West Elementary School!

#### Updates and Good News from Title I Team at West Elementary

The West Title I team has updated staff on changes related to National Fluency Norms. These changes are based upon updated research (2017) in this important area of reading. Fluency rate expectations have increased an average of 10 words per minute for each grade level. Appropriate fluency in reading is one of the biggest indicators of life long success with reading.

Third grade staff continue to respond to these changes by adding instruction through decodable text, in addition to high interest text, during Guided Reading groups for students who are at risk in reading. In this way, students are receiving a double dose of phonic skills which relates to improved decoding ability for the students. Also, for these below grade level readers, teachers are beginning to implement a short writing practice pieces related to sight words seen in text. This demonstration/ practice of the reciprocity between reading and writing will, in turn, improve both the student's fluency and comprehension rates.

The Title I team at West has also worked to support classroom teachers by providing a scope and sequence of decoding skills and high frequency words that are needed to support their students whom are performing at a primary level in an intermediate building (students in Special Education and Tier 2 students).

The Title I team in conjunction with the Special Education team create the MTSS team at West. These teachers are researching appropriate resources to purchase in order to support this increased implementation for improved fluency. Decodable text, as well as high interest text, at the primary and early intermediate level, are the main focus of purchases.

Staff at West are collaborating and working hard to improve our comprehensive Core Literacy Program. The West Title I team is also collaborating well with the Title I team from Central to continually improve the Core Literacy Program K-5 for students in Wamego School District. Staff thank Chris Cezar and the Board of Education for the opportunity for the LETRS training provided for both Central and West. This is an important part of the collaboration and growth in understanding of the research behind current best practices in Literacy, for all staff members K-5.

#### West Students Compete at Kansas State Fair!

Several students at West Elementary recently had projects from the Pottawatomie County Fair that were eligible to compete at the Kansas State Fair held from September 7th to 16th in Hutchinson, Kansas. Students with projects competing at the Kansas State Fair and their results were as follows: Jacob DeRouchey – Photography (Red), Foods and Nutrition (Purple), and Horticulture (Blue); Gavin Hamman – Photography (Blue) and Foods and Nutrition (Red); Joel Louderback – Clothing and Textiles (Blue); Elsie Rickstrew – Home Environment (Red), Clothing and Textiles (Purple), and Foods and Nutrition (Purple), Haylee Havice – Foods and Nutrition (Blue), Tasen Nickel – Foods and Nutrition (Blue), and Arden Sylvester – Foods and Nutrition (Red). #### Girls on the Run Updates for Fall 2018

Girls on the Run has begun Season III at West Elementary with coaches Robin Butler, Michelle Coleman, Darcie Gallagher, and Heather Petermann leading the way. This season we have our largest group yet with 15 participants.

Girls on the Run is a program for girls in third through fifth grade that encourages girls to recognize their individual strengths and celebrate connections with others. Each season, girls gain a better understanding of who they are and what is important to the value of teamwork and healthy relationships and how they can have a positive impact on the world.

Girls also make a meaningful contribution to their community through a team-organized Community Impact Project. Physical activity is woven into the program to inspire an appreciation for fitness and healthy habits and teach life skills including treating others with care, practicing gratitude, and managing emotions. Each season culminates with a Girls on the Run 5K event which will be held at KSU on December 1, 2018.

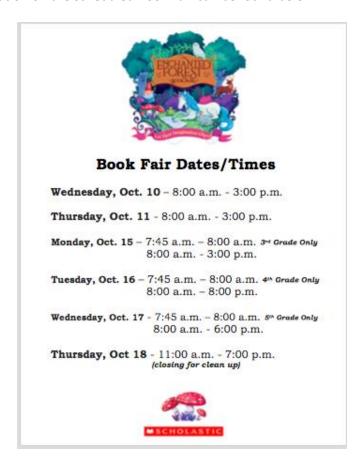

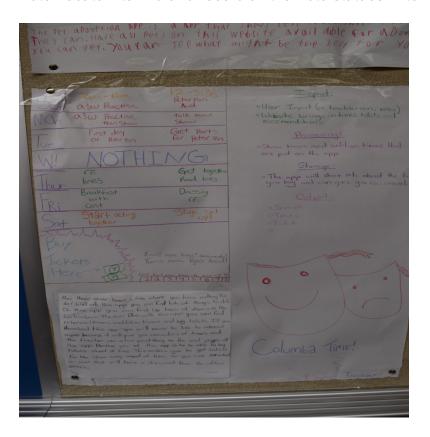

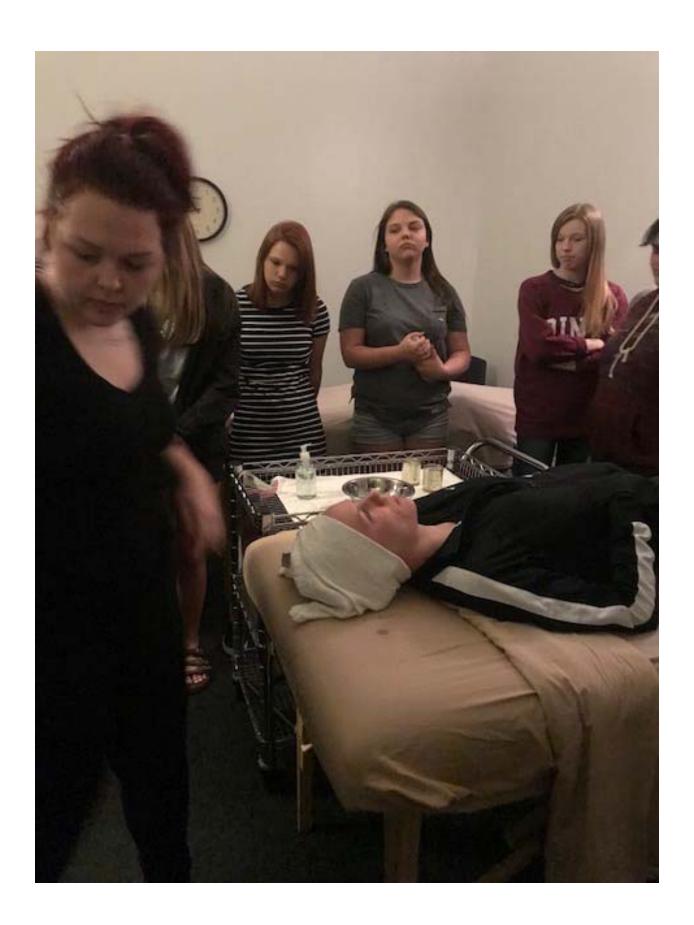
# **News from Transition**

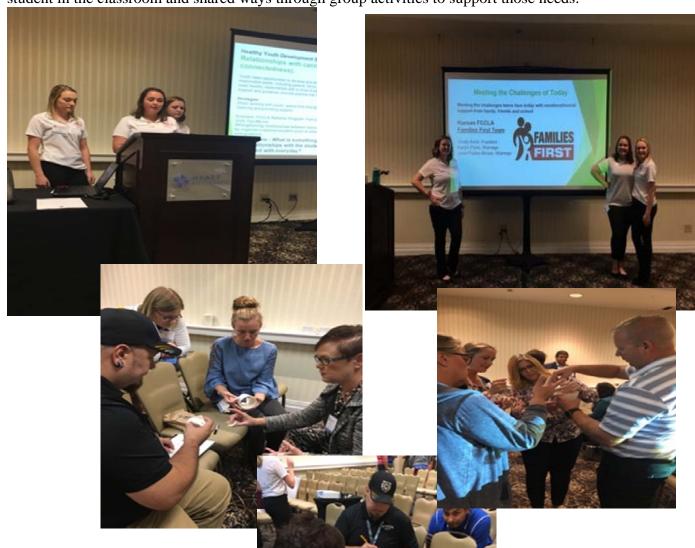

Attached you will find the USD 320 Assessment Report for the 2017-18 school year. Included in this report is a summary of the results for the following major assessments:

Early Reading Assessment (2<sup>nd</sup> grade): As you may know, KSDE no longer requires administration of an early reading assessment per se, however, I am reporting the K-2 reading data that we gather on early readers. This data is drawn from the Aims Web Plus assessment program being used to both screen and monitor reading progress.

**NWEA:** Measures of Academic Progress (MAP Assessment) Per Grade Level: The MAP assessments have been used in USD 320 beginning in fall of 2005. This assessment is a nationally normed assessment, which provides us with a solid picture of how our students' achievement compares to hundreds of thousands of students throughout the nation. The MAP assessments provide longitudinal data on individual students insofar as their growth in reading and math over time.

- **Reading:** foundational skills, language and writing, literature and informational vocabulary use, functions (K-2)/literature, informational text, vocabulary acquisition & use (3-HS)
- **Mathematics:** operations and algebraic thinking, number and operations, measurement and data, geometry (K-2)/ operations and algebraic thinking, the real complex number systems, geometry, statistics and probability (3-HS)

Once again, the MAP results for all student grade levels tested for reading and math (grades 2 through 10) indicate that our students are performing strongly on this nationally normed assessment.

Advanced Placement (High School). The AP assessments are given in the spring and the numbers of students enrolled in these courses has consistently grown over time. You will note a lower number of students took AP exams this past spring however. Students who take AP courses are then provided the opportunity to take the College Board AP Exams in the spring, with the hope of earning a score that gives college credit to universities throughout Kansas and outside of the state for work accomplished. Students were administered AP exams in the following AP courses during the 2017-18 school year: *US History, English Literature/Composition, English Language/Composition, Psychology, European History, U.S. Government & Politics, and Calculus AB, Statistics.* WHS offers a breadth of AP courses, considerably more as compared to other schools in comparable size, and we consider the AP program and these courses to be "capstone" in nature at WHS. Fifty seven WHS students took 89 AP exams this past spring (thirteen 12th graders, thirty three 11th graders, and eleven 10th graders).

#### ACT (High School)

English, Math, Reading, Science (local, state & national). The ACT is a measurement of college readiness trends. We do not have the most recent ACT report at this time; therefore, this will not be a part of the annual assessment report; I will share these results once they are available to us.

**Kansas Assessments.** Students were administered the Kansas math (3-8 & 10), English Language Arts (3-8 & 10), social studies (6, 8 & 11) and science (5, 8 and 11) assessments during the spring, 2018.

I will provide the BOE with a brief overview of the assessments in this report, and field any questions you might have regarding the results at the upcoming meeting. Please feel free to contact me if you have questions, or would like to discuss any assessment information in this report.

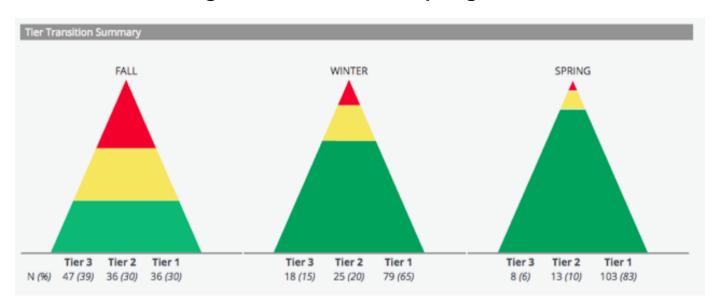

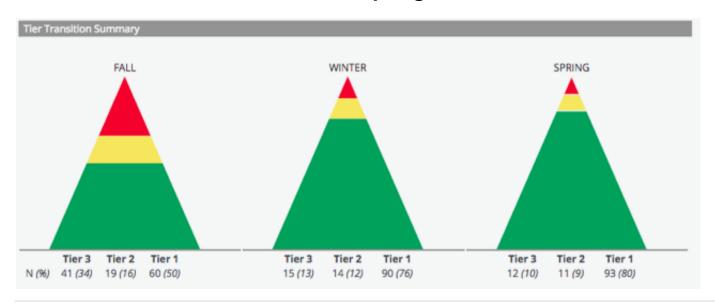

### AimsWeb ~ Grade 1: Fall 2017 to Spring 2018

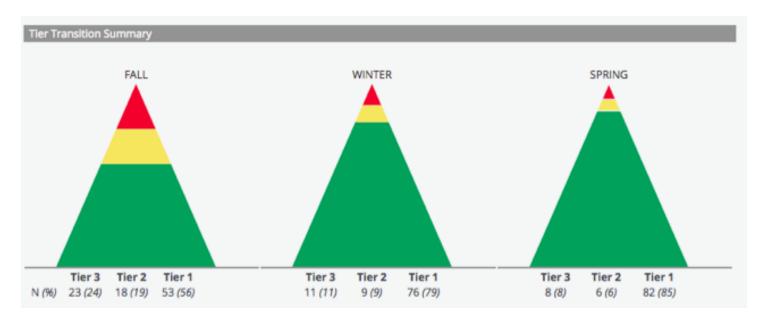

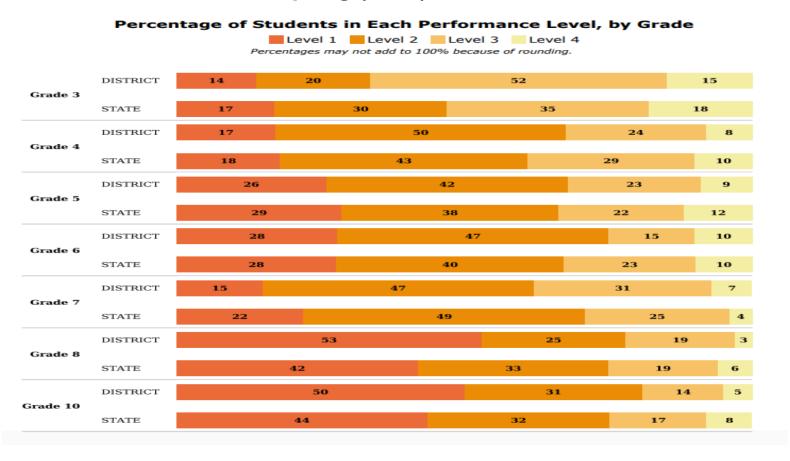

RE: Differential Para Pay

Dear BOE Members,

I am asking to differentiate our hourly pay rate for paraeducators working in our low incidence classrooms. Typically, these paraeducators are working with some of our most involved students. Staff may be required to change diapers or intervene when students have physical outbursts. These jobs are characteristically more intense and demanding which is why I am requesting an increase of \$1.00 per hour for each paraeducator assigned to one of these classrooms. With assistance from the building principals, I have identified paraeducators in the low incidence classrooms in St. George Elementary, Rock Creek JR/SR High, Central Elementary, West Elementary and Wamego High.

If approved, there are seventeen paraeducators working in these rooms that I would recommend to receive the additional \$1.00 per hour. Paraeducators work about 1,250 hours per year, so the additional pay would cost the Cooperative about \$21,250 per year ( $$1,250 \times 17 \text{ paras} = $21,250$ ). There are probably more paraeducators that are working with students with intense needs, but initially, it seemed appropriate to narrowly define the paraeducators to receive this additional stipend.

I would like to thank the board for their consideration of this proposal.

RE: Consideration of Additional Special Education Teacher

Dear BOE Members,

I am asking to add a Special Education teacher position at Wabaunsee High School because of increased number of students on IEPs. I am asking if we can add this position at the semester break. The current number of students with IEPs for Wabaunsee High is 25 students. We currently have one inter-related teacher at that building. Last year, we were able to send the teacher from Paxico Jr High to assist with the caseload. However, this year we are unable send them to Wabaunsee High because of an increase in numbers and severity of students at Paxico Jr High. When caseloads rise above twenty it is very difficult for teachers to meet the needs of their students and implement the services on the IEP.

The Cooperative will be able to request one half of categorical aid (\$15,305) which will offset the costs. Financial costs to the Cooperative will be approximately \$9,000 which will be shared by the three districts.

#### Encumbrances

An encumbrance shall be made when a purchase is made or when an approved purchase order is processed. All encumbrances shall be charged to a specific fund. All necessary encumbrances shall be made by the superintendent.

### Recommendations

Recommendations of the superintendent and professional staff concerning the district's budget allocations will be presented to the board prior to submission of the tentative draft budget. All superintendent and staff recommendations will be presented to the board no later than the regular board meeting in April each fiscal year.

### Preliminary Adoption Procedures

The superintendent will be responsible for developing the budget cover letter. It is recommended that the letter include a restatement of the goals and objectives of the district and a list of budget priorities. An explanation of line item expenditures will be included in the letter. Fund expenditures and line categories will also be explained in terms of how the budget meets the goals and objectives of the district and enhances completion of priority programs. A preliminary draft of the district's budget will be submitted by the superintendent to the board on or before July each year.

### Hearings and Reviews

The board shall conduct budget hearings according to state law.

### **Budget Transparency**

The district shall comply with the requirements of the Kansas Uniform Financial Accounting and Reporting Act and rules and regulations promulgated by the Kansas State Board of Education thereunder in maintaining, reporting, publishing on the district's website, and making available to the public specified budgetary records, forms, and information.

### Management of District Assets/Accounts

The superintendent shall establish and maintain accurate, financial management systems to meet the district's fiscal obligations, produce useful information for financial reports, and safeguard district resources. The superintendent shall ensure the district's accounting system provides ongoing

All employees, board members, consultants, vendors, contractors and other parties maintaining a business relationship with the district shall act with due diligence in duties involving the district's fiscal resources. ### Reporting Fraud

An employee who suspects fraud, impropriety, or irregularity shall promptly report those suspicions to the immediate supervisor and/or the superintendent. Any monies not immediately required for the purposes for which the monies were collected or received may be invested as provided by current statute.

#### Posting Securities

All investments of district monies shall be secured to 100% of the amount of district monies by F.D.I.C. coverage, a pledge of direct federal obligations or direct guaranteed federal agency deposits in accordance with requirements of state law. Exceptions to the required posting of securities shall be only as provided by law and approval of the board.

All offerings of monies for investment shall state the amount to be invested and the maturity date of each investment.

All banks and savings and loan associations with main or branch offices located within the county or adjoining counties of the district shall be given an opportunity to bid on all monies offered for investment. All bids shall be specified on the basis of simple interest.

### Distribution of monies for investment shall be as follows:

The treasurer or other person designated by the board shall inform each eligible bank and savings and loan association of the total amount of money to be invested on a specified date and the maturity date of the investment.

Each bank or savings and loan association bidding shall submit a single bid of the rate of interest it would pay on all or part of the funds to be invested.

Monies shall be invested with the highest bidder in such amount as the bidder will accept, and any remaining amounts shall be invested with the next highest bidders in order of interest rate offered. No bidder shall be eligible to receive any funds in the same offering at a rate lower than its single bid.

The board shall avoid negotiation of bid specifications after bids have been accepted and shall correct specifications if they are inadequately written and request new bids. If an error is discovered in the bid specifications, all bids shall be returned unopened, and the project shall be rebid using corrected and/or amended specifications.

#### Procedure

All bids must be submitted to the clerk in sealed envelopes with the name of the bidder and the date of the bid opening plainly marked in the lower left-hand corner of the envelope. All bids shall be opened publicly on the stated date and time. All bidders and other interested persons may be present when the bids are opened.

Bids may be opened by the purchasing agent or other person designated by the board, and such opening shall be witnessed by one other district employee. The bids shall then be arranged in order from low to high before they are presented to the board for action.

#### Responsible Bidder

All bids shall be awarded to the lowest responsible bidder. The board remains the sole judge of whether a bidder is "responsible." #### Unpaid Fees and Negative Account Balances

Unpaid or overdue accounts disrupt accounting practices within the district. All persons who owe overdue fees or have negative account balances with the district shall be notified of the delinquency up to three times in not less than ten day increments by the superintendent or superintendent's designee via letter sent by U.S. First Class Mail providing that the individual owes the district fees or that a specified account has insufficient funds or a negative balance and the reason for the fees or account withdrawals.

If, within ten days after the second notice was mailed, the debt is not paid in full or arrangements have not been made with the superintendent or superintendent's designee to pay it, a third and final notice shall be sent to the debtor by mail. Postage and stationary costs may be added to the original bill.

If full payment is not received by the clerk within ten days after mailing of the final notice, authorization for the enforcement of collection may be obtained through the local small claims court in compliance with Kansas statutes, the superintendent or superintendent's designee may turn the matter over to legal counsel to commence debt collection proceedings on behalf of the district, or the matter may be handled through the Kansas SetOff Program.

#### Insufficient Funds Checks

#### Option 1:

The superintendent or the superintendent's designee is authorized to request charges to be filed against a person or persons giving worthless or insufficient fund checks to the school district. In addition, the board adopts the following procedures for dealing with returned checks in the school setting.

DP Collection Procedures DP-2

Once the person is notified of the first returned check via U.S. First Class

Mail, if restitution is made within five working days from the notification being

mailed, there will be no charge for a returned check. If after a second notification

is sent, restitution is not made within an additional five working days, a fee of

\$10.00 will be charged.

• If a person has a second returned check, he/she will be notified and

assessed a \$15.00 fee, providing restitution is made within five working

days. After the second notification is mailed concerning the second

returned check, a fee of \$20.00 will be assessed.

• For a third returned check, the person will be notified, assessed a \$30.00

fee, and informed that the district and its schools will not accept any

future checks from such person. All future payments to the district or

individual schools would then need to be in the form of cash, cashier's

check, or credit/debit card payment.

• If restitution of the third check is not made within five working days

The board of education is committed to limiting the use of Emergency Safety Intervention ("ESI"), such as seclusion and restraint, with all students. Seclusion and restraint shall be used only when a student's conduct necessitates the use of an emergency safety intervention as defined below. The board of education encourages all employees to utilize other behavioral management tools, including prevention techniques, de-escalation techniques, and positive behavioral intervention strategies.

This policy shall be made available on the district website with links to the policy available on any individual school pages. In addition, this policy shall be included in at least one of the following: each school's code of conduct, school safety plan, or student handbook. Notice of the online availability of this policy shall be provided to parents during enrollment each year.

#### Definitions

"Campus police officer" means a school security officer designated by the board of education of any school district pursuant to K.S.A. 72-6146, and amendments thereto.

"Chemical Restraint" means the use of medication to control a student's violent physical behavior or restrict a student's freedom of movement.

"Emergency Safety Intervention" is the use of seclusion or physical restraint, but does not include physical escort or the use of time-out.

"Incident" means each occurrence of the use of an emergency safety intervention.

"Law enforcement officer" and "police officer" mean a full-time or parttime salaried officer or employee of the state, a county, or a city, whose duties include the prevention or detection of crime and the enforcement of criminal or traffic law of this state or any Kansas municipality. This term includes a campus police officer.

"Legitimate law enforcement purpose" means a goal within the lawful authority of an officer that is to be achieved through methods or conduct condoned by the officer's appointing authority.

"Mechanical Restraint" means any device or object used to limit a student's movement.

"Parent" means: (1) a natural parent; (2) an adoptive parent; (3) a person acting as a parent as defined in K.S.A. 72-3122(d)(2), and amendments thereto; (4) a legal guardian; (5) an education advocate for a student with an exceptionality; (6) a foster parent, unless the student is a child with an exceptionality; or (7) a student who has reached the age of majority or is an emancipated minor.

"Physical Escort" means the temporary touching or holding the hand, wrist, arm, shoulder, or back of a student who is acting out for the purpose of inducing the student to walk to a safe location.

"Physical Restraint" means bodily force used to substantially limit a student's movement, except that consensual, solicited, or unintentional contact and contact to provide comfort, assistance, or instruction shall not be deemed to be physical restraint.

"School resource officer" means a law enforcement officer or police officer employed by a local law enforcement agency who is assigned to a district through an agreement between the local law enforcement agency and the district.

"School security officer" means a person who is employed by a board of education of any school district for the purpose of aiding and supplementing state and local law enforcement agencies in which the school district is located, but is not a law enforcement officer or police officer.

"Seclusion" means placement of a student in a location where all of the following conditions are met: (1) the student is placed in an enclosed area by school personnel; (2) the student is purposefully isolated from adults and peers; and (3) the student is prevented from leaving, or reasonably believes that he or she will be prevented from leaving the enclosed area.

"Time-out" means a behavioral intervention in which a student is temporarily removed from a learning activity without being secluded.

### Prohibited Types of Restraint

All staff members are prohibited from engaging in the following actions with all students:

- Using face-down (prone) physical restraint;
- Using face-up (supine) physical restraint;
- Using physical restraint that obstructs the student's airway;
- Using physical restraint that impacts a student's primary mode of communication;

- Using chemical restraint, except as prescribed treatments for a student's medical or psychiatric condition by a person appropriately licensed to issue such treatments; and
- Use of mechanical restraint, except:
  - O Protective or stabilizing devices required by law or used in accordance with an order from a person appropriately licensed to issue the order for the device;
  - Any device used by a certified law enforcement officer to carry out law enforcement duties; or
  - o Seatbelts and other safety equipment when used to secure students during transportation.

## Use of Emergency Safety Interventions

ESI shall be used only when a student presents a reasonable and immediate danger of physical harm to such student or others with the present ability to effect such physical harm. Less restrictive alternatives to ESI, such as positive behavior interventions support, shall be deemed inappropriate or

ineffective under the circumstances by the school employee witnessing the student's behavior prior to the use of any ESI. The use of ESI shall cease as soon as the immediate danger of physical harm ceases to exist. Violent action that is destructive of property may necessitate the use of an ESI. Use of an ESI for purposes of discipline, punishment, or for the convenience of a school employee shall not meet the standard of immediate danger of physical harm.

### ESI Restrictions

A student shall not be subjected to ESI if the student is known to have a medical condition that could put the student in mental or physical danger as a result of ESI. The existence of such medical condition must be indicated in a written statement from the student's licensed health care provider, a copy of which has been provided to the school and placed in the student's file.

Such written statement shall include an explanation of the student's diagnosis, a list of any reasons why ESI would put the student in mental or physical danger, and any suggested alternatives to ESI. Notwithstanding the provisions of this subsection, a student may be subjected to ESI, if not subjecting the student to ESI would result in significant physical harm to the student or others.

## Use of Seclusion

When a student is placed in seclusion, a school employee shall be able to see and hear the student at all times.

All seclusion rooms equipped with a locking door shall be designed to ensure that the lock automatically disengages when the school employee viewing the student walks away from the seclusion room, or in case of emergency, such as fire or severe weather.

A seclusion room shall be a safe place with proportional and similar characteristics as other rooms where students frequent. Such room shall be free of any condition that could be a danger to the student, well-ventilated, and sufficiently lighted.

## **Training**

All staff members shall be trained regarding the use of positive behavioral intervention strategies, de-escalation techniques, and prevention techniques. Such training shall be consistent with nationally recognized training programs on ESI. The intensity of the training provided will depend upon the employee's position. Administrators, licensed staff members, and other staff deemed most likely to need to restrain a student will be provided more intense training than staff who do not work directly with students in the classroom. District and building administration shall make the determination of the intensity of training required by each position.

Each school building shall maintain written or electronic documentation regarding the training that was provided and a list of participants, which shall be made available for inspection by the state board of education upon request.

## Notification and Documentation

The principal or designee shall notify the parent the same day as an incident. The same-day notification requirement of this subsection shall be deemed satisfied if the school attempts at least two methods of contacting the parent. A parent may designate a preferred method of contact to receive the sameday notification. Also, a parent may agree, in writing, to receive only one sameday notification from the school for multiple incidents occurring on the same day.

Documentation of the ESI used shall be completed and provided to the student's parents no later than the school day following the day of the incident. Such written documentation shall include: (A) The events leading up to the incident; (B) student behaviors that necessitated the ESI; (C) steps taken to

transition the student back into the educational setting; (D) the date and time the incident occurred, the type of ESI used, the duration of the ESI, and the school personnel who used or supervised the ESI; (E) space or an additional form for parents to provide feedback or comments to the school regarding the incident; (F) a statement that invites and strongly encourages parents to schedule a meeting to discuss the incident and how to prevent future incidents; and (G) email and phone information for the parent to contact the school to schedule the ESI meeting. Schools may group incidents together when documenting the items in subparagraphs (A), (B) and (C) if the triggering issue necessitating the ESIs is the same.

The parent shall be provided the following information after the first and each subsequent incident during each school year: (1) a copy of this policy which indicates when ESI can be used; (2) a flyer on the parent's rights; (3) information on the parent's right to file a complaint through the local dispute resolution process (which is set forth in this policy) and the complaint process of the state board of education; and (4) information that will assist the parent in navigating the complaint process, including contact information for Families Together and the Disability Rights Center of Kansas. Upon the first occurrence of an incident of ESI, the foregoing information shall be provided in printed form or, upon the parent's written request, by email. Upon the occurrence of a second or subsequent incident, the parent shall be provided with a full and direct website address containing such information.

## Law Enforcement, School Resource, and Campus Security Officers

Campus police officers and school resource officers shall be exempt from the requirements of this policy when engaged in an activity that has a legitimate law enforcement purpose. School security officers shall not be exempt from the requirements of this policy.

If a school is aware that a law enforcement officer or school resource officer has used seclusion, physical restraint, or mechanical restraint on a student, the school shall notify the parent the same day using the parent's preferred method of contact. A school shall not be required to provide written documentation to a parent, as set forth above, regarding law enforcement use of an emergency safety intervention, or report to the state department of education any law enforcement use of an emergency safety intervention. For purposes of this subsection, mechanical restraint includes, but is not limited to, the use of handcuffs.

## Documentation of ESI Incidents

Except as specified above with regard to law enforcement or school resource officer use of emergency safety interventions, each building shall maintain documentation any time ESI is used with a student. Such documentation must include all of the following:

- Date and time of the ESI,
- Type of ESI,
- Length of time the ESI was used,
- School personnel who participated in or supervised the ESI,
- Whether the student had an individualized education program at the time of the incident,

Whether the student had a section 504 plan at the time of the incident,
 and whether the student had a behavior intervention plan at the time of
 the incident.

All such documentation shall be provided to the building principal, who shall be responsible for providing copies of such documentation to the superintendent or the superintendent's designee on at least a biannual basis. At least once per school year, each building principal or designee shall review the documentation of ESI incidents with appropriate staff members to consider the appropriateness of the use of ESI in those instances.

## Reporting Data

District administration shall report ESI data to the state department of education as required.

## Parent Right to Meeting on ESI Use

After each incident, a parent may request a meeting with the school to discuss and debrief the incident. A parent may request such meeting verbally, in writing, or by electronic means. A school shall hold a meeting requested under this subsection within 10 school days of the parent's request. The focus of any such meeting shall be to discuss proactive ways to prevent the need for emergency safety interventions and to reduce incidents in the future.

For a student with an IEP or a Section 504 plan, such student's IEP team or Section 504 plan team shall discuss the incident and consider the need to conduct a functional behavioral assessment, develop a behavior intervention plan, or amend the behavior intervention plan if already in existence.

For a student with a section 504 plan, such student's section 504 plan team shall discuss and consider the need for a special education evaluation. For students who have an individualized education program and are placed in a private school by a parent, a meeting called under this subsection shall include the parent and the private school, who shall consider whether the parent should request an individualized education program team meeting. If the parent requests an individualized education program team meeting, the private school shall help facilitate such meeting.

For a student without an IEP or Section 504 plan, the school staff and the parent shall discuss the incident and consider the appropriateness of a referral for a special education evaluation, the need for a functional behavioral assessment, or the need for a behavior intervention plan. Any such meeting shall include the student's parent, a school administrator for the school the student attends, one of the student's teachers, a school employee involved in the incident, and any other school employees designated by the school administrator as appropriate for such meeting.

The student who is the subject of such meetings shall be invited to attend the meeting at the discretion of the parent. The time for calling such a meeting may be extended beyond the 10-day limit if the parent of the student is unable to attend within that time period. Nothing in this section shall be construed to prohibit the development and implementation of a functional behavior assessment or a behavior intervention plan for any student if such student would benefit from such measures.

## Local Dispute Resolution Process

If a parent believes that an emergency safety intervention has been used on the parent's child in violation of state law or board policy, the parent may file a complaint as specified below.

The board of education encourages parents to attempt to resolve issues relating to the use of ESI informally with the building principal and/or the superintendent before filing a formal complaint with the board. Once an informal complaint is received, the administrator handling such complaint shall investigate such matter, as deemed appropriate by the administrator. In the event that the complaint is resolved informally, the administrator must provide a written report of the informal resolution to the superintendent and the parents and retain a copy of the report at the school. The superintendent will share the informal resolution with the board of education and provide a copy to the state department of education.

If the issues are not resolved informally with the building principal and/or the superintendent, the parents may submit a formal written complaint to the board of education by providing a copy of the complaint to the clerk of the board and the superintendent within thirty (30) days after the parent is informed of the incident.

Upon receipt of a formal written complaint, the board president shall assign an investigator to review the complaint and report findings to the board as a whole. Such investigator may be a board member, a school administrator selected by the board, or a board attorney. Such investigator shall be informed of the obligation to maintain confidentiality of student records and shall report the

findings of fact and recommended corrective action, if any, to the board in executive session.

Any such investigation must be completed within thirty (30) days of receipt of the formal written complaint by the board clerk and superintendent. On or before the 30<sup>th</sup> day after receipt of the written complaint, the board shall adopt written findings of fact and, if necessary, appropriate corrective action. A copy of the written findings of fact and any corrective action adopted by the board shall only be provided to the parents, the school, and the state department of education and shall be mailed to the parents and the state department within 30 days of the board's receipt of the formal complaint.

If desired, a parent may file a complaint under the state board of education administrative review process within thirty (30) days from the date a final decision is issued pursuant to the local dispute resolution process.

Unless reporting would violate the terms of any memorandum of understanding between the district and the authority to which reports would be made. The building principal shall report students who are inexcusably absent from school to the appropriate authority.

Truancy is defined as any three consecutive unexcused absences, any five unexcused absences in a semester, or seven unexcused absences in a school year, whichever comes first. School year means the period from July 1 to June 30. Students who are absent without a valid excuse for a significant part of any school day shall be considered truant.

Prior to reporting to either the Department for Children and Families (if the student is under 13) or the county or district attorney (if the student is 13 or more years of age but less than 18 years of age), a letter shall be sent to the student's parent(s) or guardian notifying them that the student's failure to attend school without a valid excuse shall result in the student being reported truant.

### Waiver of Compulsory Attendance Requirements

Students 16 or 17 years of age may be exempt from compulsory attendance regulations if the parent(s) or person acting as parent attend(s) the counseling session required by law and signs the appropriate consent and waiver form; if the student earns a GED; or if the student is exempt from compulsory attendance requirements pursuant to a court order.

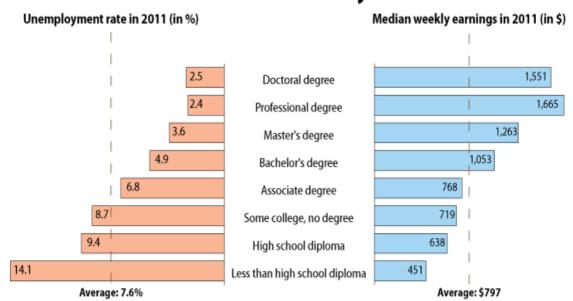

## JCAC <u>Interrogation and Investigations</u> (See EBC, GAAD, JCABB, JCEC and JHCAA)

Building administrators, school security officers, and/or others designated by the superintendent may conduct investigations and question students about violation of school rules, the student conduct code, and/or law. Unless otherwise provided herein, such investigators shall not be required to contact the student's parent, guardian, or representative prior to questioning and may request law enforcement, school resource officer(s), and/or school security officer(s) for assistance in conducting the investigations.

If there is reason to believe a violation of a criminal law has been committed, the building administrator, the superintendent's designee, and/or school security officer with authorization of the or the superintendent's designee shall notify the appropriate law enforcement agency of criminal conduct as provided in law and/or board policy and may request further investigation of the alleged violation.

When a school resource officer or campus police officer initiates an investigation of a potential violation of criminal law by a student on the officer's own initiative and not at the behest of a building administrator or the designee of the superintendent, such officer will notify the building administrator and will make a reasonable attempt to contact the student's parent, guardian, or representative prior to initiating questioning.

#### Coordination with Law Enforcement

School administrators and/or school security officers shall/may meet periodically with local law enforcement officials to discuss the district's policies and rules regarding law enforcement contacts with the district.

## Notification of Investigations Conducted by Law Enforcement Officers

When law enforcement officers initiate an investigation involving questioning of a student on a topic unrelated to a report of child abuse or neglect or to the identity of the student during school hours, the building administrator shall make a reasonable attempt to contact a parent, guardian, or representative of the student(s) prior to such questioning. Notification or attempted notification of a parent, guardian, or representative shall be documented by the administrator involved. If a student's parent, guardian, or representative is not present during such questioning of a student, the principal may be present unless otherwise specified in law or board policy.

# Child Abuse and Identity Investigations Conducted by Law Enforcement Officers

The administration shall cooperate with law enforcement officers who are conducting investigations of suspected child abuse or neglect or concerning the student's identity. For any investigations concerning known or suspected child abuse or neglect, school staff shall follow the procedures outlined in board policy GAAD instead of the requirements of this policy.

## Law Enforcement Initiated Investigations at School

In cases not involving the investigation of known or suspected child abuse or neglect or involving the student's identity, law enforcement officers shall not be permitted to initiate and conduct investigations involving the questioning of students during school hours unless the student's parent or guardian has given the school permission to allow the questioning, a valid warrant has been presented to the building administrator for such purpose, or in

demonstrated emergency situations. If a demonstrated emergency is found, the building administrator shall require identification of law enforcement officials and reasons for the interrogation or investigation of a student. If the building administrator is not satisfied with either the identification or the reason, the request shall not be granted. The building administrator shall attempt to notify the superintendent and the officer's superiors of the reasons for the refusal.

## Taking Students Into Custody

Students shall not be voluntarily released by school officials to law enforcement authorities unless the student has been placed under arrest or taken into custody by law enforcement, school resource officers, campus police officers, or Department for Children and Families ("DCF") authorities pursuant to a child abuse investigation. Except as otherwise specified in this policy, a reasonable effort shall be made to notify the student's parent, guardian, or representative when students are removed from

school for any reason. Parents shall not be notified by school officials when their child is taken into custody by DCF, school resource officers, campus police officers, and/or law enforcement as a result of allegations of abuse or neglect. Except as provided above and/or as specified in a court order or arrest warrant, if a student is taken into custody by a law enforcement officer, school resource officer, or campus police officer, building administrators shall make a good-faith effort to contact the student's parent or guardian. Notification efforts shall be documented.

When a student has been taken into custody or arrested on school premises without prior notification to the building administrator, the school

staff present shall ask the law enforcement officer to notify the building

administrator of the circumstances as quickly as possible and shall themselves

contact the building administrator with any information they have regarding the

child being taken into custody. School resource officers and campus police

Disturbance of School Environment

Law enforcement officers may be requested to assist in controlling

disturbances at school and, if necessary, to take students or other persons into

custody.

security officer employed by and designated by the board to aid and supplement

law enforcement agencies of the state, city, and county in which the school district

For the purposes of this policy, students will not be deemed to be "taken

security officer, and/or campus police officer about a violation of state law,

county resolutions, city ordinances, board policy or regulation, and/or school

rules on property owned, occupied, or operated by the school district or at the

site of a function sponsored by the school district.

## Report to Staff Member USD 320

The superintendent shall investigate the matter, and, if it is determined the student has been involved in the following, the superintendent shall provide information and the identity of the pupil to all employees who are involved, or likely to be directly involved, in teaching or providing related services to pupil:

- 1. Any student who has been expelled for conduct which endangers the safety of others:
- 2. Any student who has been expelled for commission of felony type offenses;
- 3. Any student who has been expelled for possession of a weapon;
- 4. Any student who has been adjudged to be a juvenile offender and whose offense, if committed by an adult, would constitute a felony, except a felony theft offense involving no direct threat to human life;
- 5. Any student who has been tried and convicted as an adult of any felony, except theft involving no direct threat to human life.

School District staff are required by both Federal Law and K.S.A. 72-6311 to protect the right of privacy of any student under the age of 18 and the student's family regarding personally identifiable records, files, data, and information directly related to the student and his/her family. Bullying (See EBC, GAAE, JCE, JDD, JGEC, JGECA, and KGC) JDDC **JDDC** 

The board of education prohibits bullying in any form either by any

student, staff member, or parent towards a student or by a student, staff member,

## **USD 320 Bullying Plan**

## (Also see Policies GAAE and JDDC)

Bullying means: Any intentional gesture or any intentional written, verbal, electronic, or physical act or threat either by any student, staff member, or parent towards a student or by any student, staff member or parent towards a staff member that is sufficiently severe, persistent, or pervasive that it creates an intimidating, threatening, or abusive educational environment that a reasonable person, under the circumstances, knows or should know will have the effect of:

- Harming a student or staff member, whether physically or mentally;
- Damaging a student's or staff member's property:
- Placing a student or staff member in reasonable fear of harm; or
- Placing a student or staff member in reasonable fear of damage to the student's or staff member's property.

Bullying also includes cyberbullying. "Cyberbullying" means bullying by use of any electronic communication device through means including, but not limited to, e-mail, instant messaging, text messages, blogs, mobile phones, pagers, online games, and websites.

Additionally, bullying means any form of intimidation or harassment prohibited by the board of education of the school district in policies concerning bullying adopted pursuant to K.S.A. 72-6147 or subsection (e) of K.S.A. 72-1138, and amendments thereto. USD \_\_\_will not tolerate these actions by students, staff, or parents.

For the purposes of this plan and its authorizing policies, "parent" includes a biological, adoptive, or stepparent; guardian; custodian; or other person with authority to act on behalf of a student.

Similarly, a "staff member" means any person employed by the district.

Any act of bullying by either an individual student or group of students towards a student or staff member of the district is prohibited on or while utilizing school property, in a school vehicle, or at school-sponsored activities, programs, and events. This policy applies to students who directly engage in an act of bullying, to students who, by their behavior, support another student's act of bullying, and to all staff members and parents who engage in similar behaviors.

Training concerning identifying, reporting, investigating, and preventing bullying behaviors as outlined in

district policies and this plan shall be provided to students and staff members using district resources

available for such purpose and shall be provided through school assemblies, staff development, or other

appropriate forums at least {annually/biannually}.

The board or the district administration on behalf of the board may seek student, staff, parent, and/or

community input on the adoption, revision, and/or implementation of the board's bullying policies or plan

as directed or approved by the board.

No teacher, administrator, or school district employee shall engage in, permit, or tolerate bullying.

Retaliation against a victim, good faith reporter, or a witness to bullying is prohibited. A student or staff

member who engages in an act of bullying, reprisal, retaliation or false reporting of bullying, shall be

subject to discipline in accordance with school district policy and procedures. The school administration

and/or board may take into account the following factors when determining an appropriate disciplinary

action for such prohibited conduct: the ages of the parties involved; the developmental and maturity

levels, special education needs of the parties involved, and the severity of the behavior.

Discipline guidelines for student bullying may be found in student and employee handbooks. Offenses

over time or single offenses which are severe in nature may result in discipline up to and including

suspension and/or expulsion or termination from employment. Parents participating in prohibited

bullying conduct aimed at district students and/or staff members may jeopardize their access to district

facilities; district property; school sponsored activities, programs, and events; and/or district students

and/or staff members through the district's communication systems. As appropriate, reports to local law
