Central Elementary Items for the Good November 2018

Preschool

Preschool has been exploring the season of 'fall' through the month of October. The children have been documenting the changes happening to the trees, grass, and other living things around the school through observation and taking pictures weekly. In preparation for a field trip to the pumpkin patch, the children learned the anatomy of a pumpkin. Learning vocabulary words including; stem, pulp, seeds, skin, tendril, etc. We also discussed and then observed the life-cycle of a pumpkin. While in the classroom, the children looked at pictures and videos of the life-cycle. At the pumpkin patch, the children were able to observe and identify the different stages. October is always a fun month full of hands-on, meaningful learning opportunities!




<u>Kindergarten</u>

In Kindergarten we have spent the last 9 weeks learning all about numbers 1-10. To wrap up our Module we had a Number Fair in which each Kindergarten class got to visit all the other Kindergarten rooms and see how the Numbers 1-10 have been represented. The following are

ways that we learned about these numbers.

- Finding a counting path for different arrangements, for example circular, linear and scattered arrangements
- Counting and matching that number of objects to the written numeral \square
- Ordering dot patterns and numbers in number order
- Decomposing numbers 1-10 by finding all the Hidden Partners for each numbers
- Arranging and drawing "one more" and "one less" to a given number up to 10
- Counting up and down within 10



















First Grade

This month First Grade has been exploring sound. Students got to design and create their own instrument. We've also been studying bats and specifically how bats use echolocation to navigate and find food in the dark!





Second Grade

This month the second graders have been learning about Earth and its place in the Universe. We have talked about how Earth's systems change land quickly, (like earthquakes or a volcano) and slowly, (as in weathering or erosion).

We also learned about the many types of landforms, such as, islands, peninsulas, buttes, plateaus, mountains, hills, canyons, and valleys. We have also discussed bodies of water, continents, tectonic plates and where to locate different things on a map.



Reading Specialists

Parent teacher conferences are an important time to bond with each of our student's parents. Conferences give teachers a face-to-face time to tell parents the areas their child is excelling in and to give parents specific ideas on what they can work on with their child at home. It gives us an opportunity to work together with parents to increase their child's academic success.

Central's reading and special education teachers try to make it to every conference for the students we take. This year combined, we had 149 conferences to attend. We were able to make 139 of those conferences. If we did not make the conference we made sure the teachers had a report to give the parents from us.

Every parent received their monthly monitoring report from the Title I teachers. This report includes a letter updating parents on what skill we are working on in group and any changes that have or will be made. We also include ideas and a worksheet on the specific skill that the parents can work with their child on at home.

All of us gave parents the student's AIMSweb Plus report. This report shows parents a specific skill we are working on and a chart with their child's progress. We monitor every student weekly. We will continue to keep the parents informed and updated on their child's success throughout the year.

In addition to being named the 2018 Kansas Social Studies Teacher of the Year, Ms. Rice recently found out she was selected to serve on the writing committee to review/revise the History, Government, and Social Studies Standards for Kansas. We appreciate the time and energy Ms. Rice gives to our school, district, and state to improve the quality of education for all Kansas children.

Second Step Updates for October 8 - October 22, 2018

We continued the Second Step Bullying Prevention Unit with Lesson 2 during the weeks of *October 8 and October 15* (both were short weeks with no school on October 12 or October 17/18). The third grade students learned about Reporting Bullying. All students learned that when they recognize bullying, you find a trusted adult and assertively say, "I need to report bullying." These words get the adult's attention so they can confidently report.

Lesson 2, for fourth grade and fifth grade, focused on Bystander Power. Students discussed many ways bystanders can stop bullying. The students learned the value in thinking about how the bullied student feels, the

Three Rs of Bullying (Recognize, Report, Refuse) from the bystander perspective, and what they can do the help and support fellow students.

Fourth grade students worked with a partner to make a Be Kind and Respectful poster. The posters are hung in the Commons Area. Fifth grade students worked with a partner to finish a comic. In the comic, Wallace was being bullied by some other boys at recess as bystanders were watching. The students wrote the last frame to the comic that was a happy ending for Wallace. They then shared their endings with the class.

During the week of October 22, third grade students practiced refusing bullying. They practiced saying "Stop it, that's bullying," in response to scenarios. After our discussion on the importance of assertively refusing bulling, we started our multiple intelligence survey. All students will be learning about the brain and identifying how they learn best.

Fourth grade and fifth grade students focused on understanding the responsibility of the bystanders in response to bullying. Students practiced refusing, reporting, and/or supporting when they witness bullying. They, too, started their multiple intelligence surveys and will be discussing the results later.

• At-Risk Students, School Supplies, and United Methodist Church Women

For years now, the UMW have donated thousands of dollars to our elementary schools for children in need. For most of these years, this money was used to provide "Angel Milk" to students who could not afford snack milk/juice.

Three years ago, Mrs. Dow and I approached the UMW group and asked that they consider allowing us to have some flexibility with how this money is spent in our schools for our most at-risk children, with the majority of dollars continuing to support Angel Milk.

One of the main reasons we asked for this change is due to the fact that information on students receiving free/reduced meals has become highly confidential in recent years and we have to be very careful about not identifying these students to others.

Last year, we received \$3,000 from the UMW, which is the amount we have received every year for quite some time now. We did have some carryover funds from last year, which increased the total budget.

A breakdown of how that money was spent last year follows:

- We used \$2,856.00 for angel milk/juice for students in need. First semester, we spent \$1377.60 and second semester, \$1478.40.
- We used \$61.56 to buy shoes for 3 children in need.
- We used \$142.97 to provide snacks to children who were unable to provide snacks from home.
- We used \$51.84 to purchase a new winter coat for a child in need.
- We used \$18.94 to provide medical supplies for at-risk students.
- We used \$498.40 to pay for lunches/breakfasts for at-risk children with negative meal accounts.
- o At the end of the year, we carried over \$39.04 for this school year.

We truly appreciate the generosity of the United Methodist Women and their support of our neediest students and their families!

• Parent/Teacher Conferences

Our overall attendance rate for Fall Parent/Teacher Conferences was 94%! Most classes had 95% attendance with four classes having 100% attendance! We appreciate all of the work our teachers put into to P/T Conferences to make them meaningful for parents and students.

We also appreciate our PTO for providing us with a delicious meal on Thursday night of Conferences! West Teachers enjoyed homemade soups, salad, and dessert. We are so grateful for all that our PTO does for us!

West PLC Building Leadership Team Updates

Our West PLC Building Leadership Team meets monthly to provide guidance and direction to our staff on matters regarding curriculum, instruction, assessment, and school improvement. Currently, we are working on identifying our goal areas for KESA Year 2. We will be finalizing these in the coming months and working on action plans. We also continue to focus on Kagan implementation and the meaningful use of our iPads with the 1 to 1 Initiative. We are in the process of reviewing Parent Perception data from our Fall Parent Perception Survey. We have 166 responses from our 339 families, which is almost 50%! This is outstanding! The results will be shared with the BOE at a later date after we have time to analyze them. We are also working on Literacy Alignment K-5 and hope to apply to TASN for technical assistance in the areas of reading, math, and behavior for MTSS.

Third Graders Develop Writing Trait of Organization

Third grade students were recently introduced to the writing trait of *organization*. They learned that the organization is the structure of the piece of writing. We read <u>Alexander and the Terrible, Horrible, No Good, Very Bad Day</u> as a strong example of a book with great organization. Throughout the book, we stopped and discussed the importance of having strong organization and specific examples from the text.

We have also been practicing the structure of sequencing. Students were given a set of directions for making pizza. Students had to use transition words, as well as their background knowledge, to help them put the directions in the correct order. Sequencing is a key component of well-organized piece of writing!

As a final piece of writing, students will work to research an animal and create a well-organized report. Students will research basic needs of an animal, which supports our trait of organization, while also tying in nicely to our

recent science unit. Students practiced their research together using the giraffe and then were assigned an animal of their choice. Students will use the book resource Epic! to help conduct their research of their animals food, protection, and habitat.





Third Grade Science Power of flowers: Plant Cycles and Heredity

Third grade students recently studied how plants reproduce and pass on their traits. Students first discovered how plants reproduce by exploring the process of pollination. Students had the opportunity to pollinate flowers during a hands-on activity. The students were also introduced to the process of plant domestication, which is the selection of traits based on inheritance and variation. Students explored four different Mystery Science Activities where they were able to answer the following questions: Why do plants grow flowers?, Why do plants five us fruit?, Why are some apples red and some green?, and How could you make the biggest fruit in the world?





• Author Visit with Dr. Nolan Carlson

First quarter, students in Mrs. Staats' fifth grade reading groups read <u>Vagabond Jack</u> by our local Wamego author, Dr. Nolan Carlson. Dr. Carlson is retired from Central and West Elementary Schools as the school counselor. Dr. Carlson generously donated a number of his books to West Elementary for use in the library and reading classrooms.

As the final activity of the study of <u>Vagabond Jack</u>, Dr. Carlson made an author visit to Mrs. Staats' classroom on Wednesday, October 17. He shared with students the research and preparation he did to make the story of the wolf dog Jack as realistic as possible. He also shared the other books that he has authored. The students prepared questions for Dr. Carlson, and he signed a copy of <u>Vagabond Jack</u> for each of the students.

We appreciate Dr. Carlson taking time to come and share his story and his passion for writing about nature with some of our fifth grade reading students.

• Fifth Grade Parent Tip and Important Date Handout



• Mrs. Butler Shares Native American Artifacts with Fifth Grade

Mrs. Butler visited our classrooms to share Native American artifacts that her and her father have collected over the years. She shared geographical information about where the items were found and the use of each item. This directly relates to our current social studies unit of study about Native Americans. The students thoroughly enjoyed analyzing these historical objects.





West Elementary Specialized Classes Updates from September and October of 2018
 Out of the Crayon Box - by Mrs. Havice, Central/West Elementary Art Teacher

Fourth and Fifth Grade Art:

Students at West Elementary began the school year with a review for fourth and fifth graders on color mixing from information contained on the covers of their West Elementary Art Sketchbooks. The students reviewed information with regards to the primary colors, secondary colors, and the intermediate colors.

In order to help the students better understand color mixing, they worked on creating a composition composed of small, medium, large, and extra-large circles featuring watercolor paints. The small circles depicted on their composition represent the primary colors consisting of red, yellow, and blue. The medium circles that are overlapped or crisscrossed are representative of two primary colors mixing to create a secondary color. The circles are the same size to represent that an equal amount of paint is used of each primary color when making a secondary color through color mixing. Finally comes the six pairs of intermediate colors that are created by mixing a primary and secondary color together. With the intermediate color pairs, there is one circle of the pair combinations that is larger than the other. This size difference is to note that there is more of the primary color contained within the newly created color versus the secondary color. The intermediate colors that the students mixed were: yellow-orange, yellow-green, red-orange, red-violet, blue-green, and blue-violet.



Once the colors were mixed, the students worked on filling in their background using black or gray watercolor paint. They were challenged while working with the black paint to keep the same color consistency throughout their painting. For students working with gray, they had to find a way to keep the same gray color throughout the background. This was achieved with finding a balance of paint and water.

Third Grade Art:

The third graders began their year with the same type of lesson to introduce color mixing with a few minor variations. Instead of worrying about various sized circles to indicate that more of one color was used to create the intermediate colors, they focused on what colors are produced when two colors are mixed through overlapping number threes. The students found a way to include nine pairs of overlapping or crisscrossed number threes on their papers, in addition to three number threes that were positioned on the paper individually. The individual number threes are representative of the primary colors. In order to understand overlapping, the students covered one of their number threes to reveal the opposite number three featured in the pair. They painted the portions of the number three that they could see at that time. Once the recently painted number had time to dry, the child covered the first number three they painted to reveal what they needed to paint for the second number three. The areas that managed to remain unpainted were the locations that the child then painted with the color produced from mixing their two colors.

The children will also be painting in the background of their paintings with either gray or black watercolor paint. They will be working on finding a balance between paint and water to produce the color that they feel would look better for their composition design.

Counselor's Corner - by Robin Butler, West Elementary Counselor

During September lessons, in addition to Second Step activities, all the students at West have been learning about mindset. Mindset is your beliefs about intelligence. Fixed mindset beliefs are that your intelligence and talent are fixed and you can't really change how smart you are. Growth mindset beliefs are that you can grow your intelligence and talent with practice and effort. The students have discussed the difference between a fixed and growth mindset and are learning to identify their own beliefs. To help identify their beliefs, students took the Mindset Survey that you can also download and take. We will continue with our mindset work this month as we discuss the brain and learning.

In October, during counseling classes, our lessons have been about bullying and how to Recognize, Report and Refuse bullying. Students have had lots of opportunities to practice these skills during role playing in the classroom and partner work. They anonymously took a Snapshot Survey to provide their perceptions of bullying problems at our school.

The students have also been learning about how the brain is like a muscle. First, we watched a video about the brain and how neurons connect when we learn. Then we discussed the research that proves the brain can get stronger and changes as we learn. Challenging ourselves is an important part of strengthening the brain.

Finally, in October, the students are working on completing a multiple intelligence survey. We will be discussing the results and what they mean over the next couple of months.

Library News - by Mrs. Solida, Central/West Elementary Librarian

Students in third, fourth, and fifth grade have been working on learning how to utilize the library catalog. They learned how to search by title, author, and keyword and how to find more detailed information about a book title in the book record. Students then practiced using the catalog on paper. Then, they completed task cards that required a variety of key word searches and actually located the book in the library.

The Scholastic Book Fair ended the quarter on a high note. We had several families visit the fair and we will receive over \$1,500 to spend on Scholastic Books for our school and library! Wow! Thanks to everyone who helped make it so successful!





Musical Notes - by Mrs. Hermesch, West Elementary Music Teacher

West Junior Raiders Choir:

I am happy to report that we have 32 fifth grade students participating in our morning choir. They will have their first performance on November 15th at 7:00 pm in the West Elementary Gym.

Third Grade Music Class:

In September, we learned about the treble clef staff and how to identify the pitches on the staff. We also briefly started playing their recorders. We learned the fingerings for B, A, and G. In October, we started their concert music. The performance of "Flakes" will be November 19th with Mrs. Haynes', Mrs. Wilber's and Mrs. Williams' classes performing at 6:00 pm and Mrs. Ruby's and Mrs. Blume's classes performing at 7:00 pm.

Fourth Grade Music Class:

In September, we reviewed treble clef note identification. We also reviewed pitches B, A, G, and Low E on the recorder. They did their first composition activity where they performed the song "Peas Porridge Hot" on recorder and the small groups performed their "compositions" with body percussion of their choice. In October,

we performed "Mr. Bones" and "Get Down". We also started our second composition "Candy Corn Compositions". Students were given a template and manipulatives to create rhythm patterns. The students could then choose names for their "creatures" and body percussion to perform for the class. They are now working on substituting notation for the "creature names". Students will begin concert music soon for their performance on January 28th, 2019.

Fifth Grade Music Class:

We have done a variety of music activities in September and October. We have reviewed counting rhythms by playing Rhythm Bingo in small groups. We also reviewed treble clef note identification. We did an improvisation activity call "Operator, Operator" where students had to improvise their own beat patterns. We just finished singing the song "I Hear the Windmill" and started "Shoo My Love" in two parts and learning how to read two-part choir music. Our music student intern, Jeremey Reynolds, is currently working on teaching sixteenth note and sixteenth/eighth note rhythm patterns.

Afternoon Fifth Grade Classes:

We have had fun reading the books "Possum Come A Knockin" and "The Little Old Lady Who Is Not Afraid of Anything" and adding music to the reading. Recently, we began singing call and response songs.

P.E. Happenings - by Mr. Pluff, West Physical Education Teacher

September:

At the beginning of the school year, we began introducing team building/and team work games, as these activities are a central theme throughout the school year. We incorporated these skills into "Capture the Flag". We played 4-corner Capture the Flag, where each team had to work together to defend off the other three teams, while still trying to capture as many flags as possible. In the middle of September, we had our first "Fitness Week" of the year. Students did various circuit workouts throughout the week. We ended the month with our Volleyball Unit, where we began with skills and progressed to small-sided team games.

October:

Our first two units of the month incorporated Health and Nutrition. During our workouts, we talked about cardiovascular health and things we can do to better take care of our heart. In our Nutrition Unit we talked about different foods and how they give our body energy. We talked about what a macronutrient is and how they provide our bodies with energy.

Technology News - by Mrs. Benz, Central/West Elementary Technology Teacher

Students in third, fourth, and fifth grades are just finishing their Green Screen projects. They first saved appropriate and copyright free background images. Then they took pictures of themselves in front of our new Green Screen. Students used an app called Doink to upload images in layers with the background first, themselves in the middle, and if they chose a clip art image on the top layer. We had students falling off cliffs, swimming in the Ocean, becoming part of their favorite football team or just hanging out in a wonderful setting all through the green screen app. These images were then saved and sent to Seesaw and Google Classroom.









All students also spent time improving their keyboarding skills. A program called Type to Learn is used in school and can also be used at home with a username and password that students have in the notes section of their iPads. Another program called Typing.com can be used without a login or password for review in any setting.

The fourth graders were able to move forward with a few more objectives. Fourth grade students were introduced to Google Earth. They found their homes and major landmarks on the Santa Fe Trail. Soon they will start an Everfi money management program.

The fifth graders used a Beta version of the new Scratch 3.0 program to try coding at another level. We just received a 3D printer, so they are excitedly waiting for their chance to create a 3D CAD image to print.



7th Grade ELA Mock Trials:

7th graders read Edgar Allan Poe's short story *The Tell-Tale Heart*. After reading and analyzing the text, they were divided into three groups for a mock trial: prosecution, defense, and jury. While the guilt of the narrator was never in question (he admitted to committing the murder), his sanity was. Prosecution was arguing for the narrator to either be put in prison for life or to be executed for his crime. However, the defense was arguing that the narrator should be committed to a mental institution to receive the help he needs. Overall, I was incredibly impressed with the dedication students showed in preparing for the mock trial. Students played a variety of roles including head lawyer, assistant lawyer, witnesses, experts, and rebuttal lawyers. They worked with their teams to prepare and practice questions and answers in preparation for the mock trial. Each section of my 7th grade classes brought to trial different arguments, evidence, and testimony that demonstrated high levels of understanding of the text as well as its overarching themes. (Mrs. Cora Johnston's class)

Students read Poe's infamous short story "The Tell-Tale Heart". They were then asked, over the course of several days, to evaluate the sanity of the narrator and to argue that either A) he is guilty of murder and should be sentenced to life in prison or B) that he is insane and should be institutionalized. Students were assigned to one of these sides and each chose a different role: lawyer, witness, character witness, topical expert, or rebuttal lawyer. On Oct. 18, we gathered in the library, before juries of their peers, teachers, and parents, to argue the case. Two classes determined the man was guilty, and two classes decided he was insane. Officer Coleman served as the bailiff for a few classes, and Ms. Morris served as the judge. Some students chose to dress up and bring lawyer-like accessories to complete the authenticity. Overall, students were tremendously engaged and a few now have an interest in a career in law! (Mrs. Borror's class)



Circle of Friends:


Band







Wednesday, December 12, 2018

European History Advanced Placement, Honors World History, and Gifted SIP students

I request your consideration and approval of the Wamego High School European History and World History classes tours of the art at the Nelson-Atkins Gallery on Wednesday, December 12th. Our trip will give the students a primary source experience that videos and textbooks can never provide. The Nelson-Atkins Gallery is organized by art periods and genres and the tour will allow all of the students to see sequence and change of art throughout history.

The visit to the Nelson-Atkins Art Gallery takes on special significance because of the recently revised AP testing requirements for the course. The students are assessed on their ability to interpret, analyze, and understand the significance of primary documents and artifacts and the Art Gallery provides the optimal experience to be exposed to several of these specific primary sources. We are also including the new Honors World History class, as well as the students in the Gifted program (many of whom are in either EP Euro or Honors World History).

An additional opportunity in this year's visit to the Nelson-Atkins Gallery will be that our tour of the gallery will be self-guided. Self-guided will require research prior to the trip to locate, explore, and evaluate the art in advance of our trip.

In addition to the historical importance of art in Europe from the Renaissance to today a significant portion of the European History course focuses on the social, economic, religious, and political themes in European History. These themes are both explicit and implicit in the artwork displayed at the Nelson-Atkins Gallery.

The European History class has 19 students enrolled, the Honors World History class has 20 students, and the gifted program will be bringing 9 students (a total of 48) The trip will require a bus and driver for the trip as well as the expense of substitute teachers to cover our classes for the day. Students, teacher, and chaperones will pay for their lunches and entrance to the Gallery is free. Volunteers will be included if more adult supervision is needed for the trip. If any administrator or board member wishes to attend please let us know. We would welcome the company and the experience is exceptional.

Understanding our economic adversity and the restraints that have been placed on academic field trips, I still wish to pursue approval for this trip. Our European History course is based on the considerable significance of European Art and the interpretation of primary historical artifacts and the Nelson-Atkins Art Gallery is a treasured resource.

<u>Priorities</u>

Deadlines and Schedules

Deadlines and time schedules shall be established by the board.

Encumbrances

An encumbrance shall be made when a purchase is made or when an approved purchase order is processed. All encumbrances shall be charged to a specific fund. All necessary encumbrances shall be made by the superintendent.

Recommendations

Recommendations of the superintendent and professional staff concerning the district's budget allocations will be presented to the board prior to submission of the tentative draft budget. All superintendent and staff recommendations will be presented to the board no later than the regular board meeting in April each fiscal year.

Preliminary Adoption Procedures

The superintendent will be responsible for developing the budget cover letter. It is recommended that the letter include a restatement of the goals and objectives of the district and a list of budget priorities. An explanation of line item expenditures will be included in the letter. Fund expenditures and line categories will also be explained in terms of how the budget meets the goals and objectives of the district and enhances completion of priority programs. A preliminary draft of the district's budget will be submitted by the superintendent to the board on or before July each year.

Hearings and Reviews

The board shall conduct budget hearings according to state law.

Budget Transparency

The district shall comply with the requirements of the Kansas Uniform Financial Accounting and Reporting Act and rules and regulations promulgated by the Kansas State Board of Education thereunder in maintaining, reporting, publishing on the district's website, and making available to the public specified budgetary records, forms, and information.

Management of District Assets/Accounts

The superintendent shall establish and maintain accurate, financial management systems to meet the district's fiscal obligations, produce useful information for financial reports, and safeguard district resources. The superintendent shall ensure the district's accounting system provides ongoing

DE Fraud Prevention and Investigation

All employees, board members, consultants, vendors, contractors and other parties maintaining a business relationship with the district shall act with due diligence in duties involving the district's fiscal resources. The superintendent shall develop internal controls that aid in the prevention and detection of fraud, financial impropriety, or irregularity.

Reporting Fraud

An employee who suspects fraud, impropriety, or irregularity shall promptly report those suspicions to the immediate supervisor and/or the superintendent. If the superintendent is the subject of the complaint, reports shall be made to the board president or the board's legal counsel. The superintendent shall have primary responsibility for any investigations, in coordination with legal counsel and other internal or external departments and agencies as appropriate.

Whistleblowers

The district encourages complaints, reports, or inquiries about illegal practices or violations of district policies, including illegal or improper conduct by the district, its leadership or by others on its behalf. Reports could include, but not be limited to, financial improprieties, accounting, or audit matters, ethical violations, or other similar illegal or improper practices or policies. The district prohibits retaliation by or on behalf of the district against staff members who make good faith complaints, reports, or inquiries under this policy or for participations in a review or investigation under this policy. This protection extends to those whose allegations are made in good faith but prove to be mistaken. The district reserves the right to discipline persons who make bad faith,

knowingly false, or vexatious complaints, reports or inquiries or who otherwise

Complaints, reports, or inquiries may be made under this policy on a

The investment of school district monies shall be the responsibility of the superintendent, business manager, and/or the district treasurer.

Any monies not immediately required for the purposes for which the monies were collected or received may be invested as provided by current statute.

Posting Securities

All investments of district monies shall be secured to 100% of the amount of district monies by F.D.I.C. coverage, a pledge of direct federal obligations or direct guaranteed federal agency deposits in accordance with requirements of state law. Exceptions to the required posting of securities shall be only as provided by law and approval of the board.

All offerings of monies for investment shall state the amount to be invested and the maturity date of each investment.

All banks and savings and loan associations with main or branch offices located within the county or adjoining counties of the district shall be given an opportunity to bid on all monies offered for investment. All bids shall be specified on the basis of simple interest.

Distribution of monies for investment shall be as follows:

The treasurer or other person designated by the board shall inform each eligible bank and savings and loan association of the total amount of money to be invested on a specified date and the maturity date of the investment.

Each bank or savings and loan association bidding shall submit a single bid of the rate of interest it would pay on all or part of the funds to be invested.

Monies shall be invested with the highest bidder in such amount as the bidder will accept, and any remaining amounts shall be invested with the next highest bidders in order of interest rate offered. No bidder shall be eligible to receive any funds in the same offering at a rate lower than its single bid.

No bid less than the most recently determined investment rate as determined by the state treasurer shall be accepted. No funds will be invested for maturities of more than two years.

Any monies not otherwise invested in eligible banks and savings and loans located in the district due to their inability, for whatever reason, to accept the funds, shall be invested in secured deposits in banks or savings and loans which have offices located in counties in which a part of the school district is located or in adjoining counties.

Any monies not invested in banks and savings and loans in the district or located in counties in which a part of the school district is located may be invested in the municipal investment pool fund or United States Treasury bills or notes as authorized by Kansas law.

Monies available for reinvestment as a result of maturities may be reinvested with the bank or association holding such monies provided the bank or savings and loan association agrees to pay the same or higher rate as that offered by the highest bidder at the time of re-offer.

Bid Specifications

All bid specifications shall be written by the district's purchasing agent and shall include required characteristics and quality standards. Specifications shall include, when necessary: required performance, surety, bid, and statutory bond information; compliance with preferential bid law; financial statements; the board's right to reject any or all bids; compliance with all federal, state, and local laws, ordinances, and regulations; the date, time, and place for the opening of bids; and other items as the board directs.

The board shall avoid negotiation of bid specifications after bids have been accepted and shall correct specifications if they are inadequately written and request new bids. If an error is discovered in the bid specifications, all bids shall be returned unopened, and the project shall be rebid using corrected and/or amended specifications.

Procedure

All bids must be submitted to the clerk in sealed envelopes with the name of the bidder and the date of the bid opening plainly marked in the lower left-hand corner of the envelope. All bids shall be opened publicly on the stated date and time. All bidders and other interested persons may be present when the bids are opened.

Bids may be opened by the purchasing agent or other person designated by the board, and such opening shall be witnessed by one other district employee. The bids shall then be arranged in order from low to high before they are presented to the board for action.

Responsible Bidder

All bids shall be awarded to the lowest responsible bidder. The board remains the sole judge of whether a bidder is "responsible." Criteria that may be used to judge whether the bidder is responsible by way of illustration and not limitation, are: financial standing, reputation, experience, prior working relationship with the district, resources, facilities, judgment, and efficiency.

Unpaid Fees and Negative Account Balances

Unpaid or overdue accounts disrupt accounting practices within the district. All persons who owe overdue fees or have negative account balances with the district shall be notified of the delinquency up to three times in not less than ten day increments by the superintendent or superintendent's designee via letter sent by U.S. First Class Mail providing that the individual owes the district fees or that a specified account has insufficient funds or a negative balance and the reason for the fees or account withdrawals.

If, within ten days after the second notice was mailed, the debt is not paid in full or arrangements have not been made with the superintendent or superintendent's designee to pay it, a third and final notice shall be sent to the debtor by mail. Postage and stationary costs may be added to the original bill.

If full payment is not received by the clerk within ten days after mailing of the final notice, authorization for the enforcement of collection may be obtained through the local small claims court in compliance with Kansas statutes, the superintendent or superintendent's designee may turn the matter over to legal counsel to commence debt collection proceedings on behalf of the district, or the matter may be handled through the Kansas SetOff Program.

Insufficient Funds Checks

Option 1:

The superintendent or the superintendent's designee is authorized to request charges to be filed against a person or persons giving worthless or insufficient fund checks to the school district. In addition, the board adopts the following procedures for dealing with returned checks in the school setting.

Once the person is notified of the first returned check via U.S. First Class

Mail, if restitution is made within five working days from the notification being

mailed, there will be no charge for a returned check. If after a second notification

is sent, restitution is not made within an additional five working days, a fee of

\$10.00 will be charged.

• If a person has a second returned check, he/she will be notified and

assessed a \$15.00 fee, providing restitution is made within five working

days. After the second notification is mailed concerning the second

returned check, a fee of \$20.00 will be assessed.

• For a third returned check, the person will be notified, assessed a \$30.00

fee, and informed that the district and its schools will not accept any

future checks from such person. All future payments to the district or

individual schools would then need to be in the form of cash, cashier's

check, or credit/debit card payment.

• If restitution of the third check is not made within five working days

from mailing the final notification, the superintendent or

superintendent's designee will be notified, and the superintendent or

superintendent's designee may turn the matter over to the county

attorney for legal action.

Option 2:

The superintendent or the superintendent's designee is authorized to retain

the services of a bad check collection agency to collect funds due to the district

upon receipt of insufficient funds checks.

The board of education is committed to limiting the use of Emergency Safety Intervention ("ESI"), such as seclusion and restraint, with all students. Seclusion and restraint shall be used only when a student's conduct necessitates the use of an emergency safety intervention as defined below. The board of education encourages all employees to utilize other behavioral management tools, including prevention techniques, de-escalation techniques, and positive behavioral intervention strategies.

This policy shall be made available on the district website with links to the policy available on any individual school pages. In addition, this policy shall be included in at least one of the following: each school's code of conduct, school safety plan, or student handbook. Notice of the online availability of this policy shall be provided to parents during enrollment each year.

Definitions

"Campus police officer" means a school security officer designated by the board of education of any school district pursuant to K.S.A. 72-6146, and amendments thereto.

"Chemical Restraint" means the use of medication to control a student's violent physical behavior or restrict a student's freedom of movement.

"Emergency Safety Intervention" is the use of seclusion or physical restraint, but does not include physical escort or the use of time-out.

"Incident" means each occurrence of the use of an emergency safety intervention.

"Law enforcement officer" and "police officer" mean a full-time or parttime salaried officer or employee of the state, a county, or a city, whose duties include the prevention or detection of crime and the enforcement of criminal or traffic law of this state or any Kansas municipality. This term includes a campus police officer.

"Legitimate law enforcement purpose" means a goal within the lawful authority of an officer that is to be achieved through methods or conduct condoned by the officer's appointing authority.

"Mechanical Restraint" means any device or object used to limit a student's movement.

"Parent" means: (1) a natural parent; (2) an adoptive parent; (3) a person acting as a parent as defined in K.S.A. 72-3122(d)(2), and amendments thereto; (4) a legal guardian; (5) an education advocate for a student with an exceptionality; (6) a foster parent, unless the student is a child with an exceptionality; or (7) a student who has reached the age of majority or is an emancipated minor.

"Physical Escort" means the temporary touching or holding the hand, wrist, arm, shoulder, or back of a student who is acting out for the purpose of inducing the student to walk to a safe location.

"Physical Restraint" means bodily force used to substantially limit a student's movement, except that consensual, solicited, or unintentional contact and contact to provide comfort, assistance, or instruction shall not be deemed to be physical restraint.

"School resource officer" means a law enforcement officer or police officer employed by a local law enforcement agency who is assigned to a district through an agreement between the local law enforcement agency and the district.

"School security officer" means a person who is employed by a board of education of any school district for the purpose of aiding and supplementing state and local law enforcement agencies in which the school district is located, but is not a law enforcement officer or police officer.

"Seclusion" means placement of a student in a location where all of the following conditions are met: (1) the student is placed in an enclosed area by school personnel; (2) the student is purposefully isolated from adults and peers; and (3) the student is prevented from leaving, or reasonably believes that he or she will be prevented from leaving the enclosed area.

"Time-out" means a behavioral intervention in which a student is temporarily removed from a learning activity without being secluded.

Prohibited Types of Restraint

All staff members are prohibited from engaging in the following actions with all students:

- Using face-down (prone) physical restraint;
- Using face-up (supine) physical restraint;
- Using physical restraint that obstructs the student's airway;
- Using physical restraint that impacts a student's primary mode of communication;

- Using chemical restraint, except as prescribed treatments for a student's medical or psychiatric condition by a person appropriately licensed to issue such treatments; and
- Use of mechanical restraint, except:
 - o Protective or stabilizing devices required by law or used in accordance with an order from a person appropriately licensed to issue the order for the device:
 - Any device used by a certified law enforcement officer to carry out law enforcement duties; or
 - o Seatbelts and other safety equipment when used to secure students during transportation.

Use of Emergency Safety Interventions

ESI shall be used only when a student presents a reasonable and immediate danger of physical harm to such student or others with the present ability to effect such physical harm. Less restrictive alternatives to ESI, such as positive behavior interventions support, shall be deemed inappropriate or

ineffective under the circumstances by the school employee witnessing the student's behavior prior to the use of any ESI. The use of ESI shall cease as soon as the immediate danger of physical harm ceases to exist. Violent action that is destructive of property may necessitate the use of an ESI. Use of an ESI for purposes of discipline, punishment, or for the convenience of a school employee shall not meet the standard of immediate danger of physical harm.

ESI Restrictions

A student shall not be subjected to ESI if the student is known to have a medical condition that could put the student in mental or physical danger as a result of ESI. The existence of such medical condition must be indicated in a written statement from the student's licensed health care provider, a copy of which has been provided to the school and placed in the student's file.

Such written statement shall include an explanation of the student's diagnosis, a list of any reasons why ESI would put the student in mental or physical danger, and any suggested alternatives to ESI. Notwithstanding the provisions of this subsection, a student may be subjected to ESI, if not subjecting the student to ESI would result in significant physical harm to the student or others.

Use of Seclusion

When a student is placed in seclusion, a school employee shall be able to see and hear the student at all times.

All seclusion rooms equipped with a locking door shall be designed to ensure that the lock automatically disengages when the school employee viewing the student walks away from the seclusion room, or in case of emergency, such as fire or severe weather.

A seclusion room shall be a safe place with proportional and similar characteristics as other rooms where students frequent. Such room shall be free of any condition that could be a danger to the student, well-ventilated, and sufficiently lighted.

Training

All staff members shall be trained regarding the use of positive behavioral intervention strategies, de-escalation techniques, and prevention techniques. Such training shall be consistent with nationally recognized training programs on ESI. The intensity of the training provided will depend upon the employee's position. Administrators, licensed staff members, and other staff deemed most likely to need to restrain a student will be provided more intense training than staff who do not work directly with students in the classroom. District and building administration shall make the determination of the intensity of training required by each position.

Each school building shall maintain written or electronic documentation regarding the training that was provided and a list of participants, which shall be made available for inspection by the state board of education upon request.

Notification and Documentation

The principal or designee shall notify the parent the same day as an incident. The same-day notification requirement of this subsection shall be deemed satisfied if the school attempts at least two methods of contacting the parent. A parent may designate a preferred method of contact to receive the sameday notification. Also, a parent may agree, in writing, to receive only one sameday notification from the school for multiple incidents occurring on the same day.

Documentation of the ESI used shall be completed and provided to the student's parents no later than the school day following the day of the incident. Such written documentation shall include: (A) The events leading up to the incident; (B) student behaviors that necessitated the ESI; (C) steps taken to

transition the student back into the educational setting; (D) the date and time the incident occurred, the type of ESI used, the duration of the ESI, and the school personnel who used or supervised the ESI; (E) space or an additional form for parents to provide feedback or comments to the school regarding the incident; (F) a statement that invites and strongly encourages parents to schedule a meeting to discuss the incident and how to prevent future incidents; and (G) email and phone information for the parent to contact the school to schedule the ESI meeting. Schools may group incidents together when documenting the items in subparagraphs (A), (B) and (C) if the triggering issue necessitating the ESIs is the same.

The parent shall be provided the following information after the first and each subsequent incident during each school year: (1) a copy of this policy which indicates when ESI can be used; (2) a flyer on the parent's rights; (3) information on the parent's right to file a complaint through the local dispute resolution process (which is set forth in this policy) and the complaint process of the state board of education; and (4) information that will assist the parent in navigating the complaint process, including contact information for Families Together and the Disability Rights Center of Kansas. Upon the first occurrence of an incident of ESI, the foregoing information shall be provided in printed form or, upon the parent's written request, by email. Upon the occurrence of a second or subsequent incident, the parent shall be provided with a full and direct website address containing such information.

Law Enforcement, School Resource, and Campus Security Officers

Campus police officers and school resource officers shall be exempt from the requirements of this policy when engaged in an activity that has a legitimate law enforcement purpose. School security officers shall not be exempt from the requirements of this policy.

If a school is aware that a law enforcement officer or school resource officer has used seclusion, physical restraint, or mechanical restraint on a student, the school shall notify the parent the same day using the parent's preferred method of contact. A school shall not be required to provide written documentation to a parent, as set forth above, regarding law enforcement use of an emergency safety intervention, or report to the state department of education any law enforcement use of an emergency safety intervention. For purposes of this subsection, mechanical restraint includes, but is not limited to, the use of handcuffs.

Documentation of ESI Incidents

Except as specified above with regard to law enforcement or school resource officer use of emergency safety interventions, each building shall maintain documentation any time ESI is used with a student. Such documentation must include all of the following:

- Date and time of the ESI,
- Type of ESI,
- Length of time the ESI was used,
- School personnel who participated in or supervised the ESI,
- Whether the student had an individualized education program at the time of the incident,

GAAF Emergency Safety Interventions GAAF-9

Whether the student had a section 504 plan at the time of the incident,
 and whether the student had a behavior intervention plan at the time of
 the incident.

All such documentation shall be provided to the building principal, who shall be responsible for providing copies of such documentation to the superintendent or the superintendent's designee on at least a biannual basis. At least once per school year, each building principal or designee shall review the documentation of ESI incidents with appropriate staff members to consider the appropriateness of the use of ESI in those instances.

Reporting Data

District administration shall report ESI data to the state department of education as required.

Parent Right to Meeting on ESI Use

After each incident, a parent may request a meeting with the school to discuss and debrief the incident. A parent may request such meeting verbally, in writing, or by electronic means. A school shall hold a meeting requested under this subsection within 10 school days of the parent's request. The focus of any such meeting shall be to discuss proactive ways to prevent the need for emergency safety interventions and to reduce incidents in the future.

For a student with an IEP or a Section 504 plan, such student's IEP team or Section 504 plan team shall discuss the incident and consider the need to conduct a functional behavioral assessment, develop a behavior intervention plan, or amend the behavior intervention plan if already in existence.

For a student with a section 504 plan, such student's section 504 plan team shall discuss and consider the need for a special education evaluation. For students who have an individualized education program and are placed in a private school by a parent, a meeting called under this subsection shall include the parent and the private school, who shall consider whether the parent should request an individualized education program team meeting. If the parent requests an individualized education program team meeting, the private school shall help facilitate such meeting.

For a student without an IEP or Section 504 plan, the school staff and the parent shall discuss the incident and consider the appropriateness of a referral for a special education evaluation, the need for a functional behavioral assessment, or the need for a behavior intervention plan. Any such meeting shall include the student's parent, a school administrator for the school the student attends, one of the student's teachers, a school employee involved in the incident, and any other school employees designated by the school administrator as appropriate for such meeting.

The student who is the subject of such meetings shall be invited to attend the meeting at the discretion of the parent. The time for calling such a meeting may be extended beyond the 10-day limit if the parent of the student is unable to attend within that time period. Nothing in this section shall be construed to prohibit the development and implementation of a functional behavior assessment or a behavior intervention plan for any student if such student would benefit from such measures.

Local Dispute Resolution Process

If a parent believes that an emergency safety intervention has been used on the parent's child in violation of state law or board policy, the parent may file a complaint as specified below.

The board of education encourages parents to attempt to resolve issues relating to the use of ESI informally with the building principal and/or the superintendent before filing a formal complaint with the board. Once an informal complaint is received, the administrator handling such complaint shall investigate such matter, as deemed appropriate by the administrator. In the event that the complaint is resolved informally, the administrator must provide a written report of the informal resolution to the superintendent and the parents and retain a copy of the report at the school. The superintendent will share the informal resolution with the board of education and provide a copy to the state department of education.

If the issues are not resolved informally with the building principal and/or the superintendent, the parents may submit a formal written complaint to the board of education by providing a copy of the complaint to the clerk of the board and the superintendent within thirty (30) days after the parent is informed of the incident.

Upon receipt of a formal written complaint, the board president shall assign an investigator to review the complaint and report findings to the board as a whole. Such investigator may be a board member, a school administrator selected by the board, or a board attorney. Such investigator shall be informed of the obligation to maintain confidentiality of student records and shall report the

findings of fact and recommended corrective action, if any, to the board in executive session.

Any such investigation must be completed within thirty (30) days of receipt of the formal written complaint by the board clerk and superintendent. On or before the 30th day after receipt of the written complaint, the board shall adopt written findings of fact and, if necessary, appropriate corrective action. A copy of the written findings of fact and any corrective action adopted by the board shall only be provided to the parents, the school, and the state department of education and shall be mailed to the parents and the state department within 30 days of the board's receipt of the formal complaint.

If desired, a parent may file a complaint under the state board of education administrative review process within thirty (30) days from the date a final decision is issued pursuant to the local dispute resolution process.



JCAC <u>Interrogation and Investigations</u> (See EBC, GAAD, JCABB, JCEC and JHCAA)

Building administrators, school security officers, and/or others designated by the superintendent may conduct investigations and question students about violation of school rules, the student conduct code, and/or law. Unless otherwise provided herein, such investigators shall not be required to contact the student's parent, guardian, or representative prior to questioning and may request law enforcement, school resource officer(s), and/or school security officer(s) for assistance in conducting the investigations.

If there is reason to believe a violation of a criminal law has been committed, the building administrator, the superintendent's designee, and/or school security officer with authorization of the or the superintendent's designee shall notify the appropriate law enforcement agency of criminal conduct as provided in law and/or board policy and may request further investigation of the alleged violation.

When a school resource officer or campus police officer initiates an investigation of a potential violation of criminal law by a student on the officer's own initiative and not at the behest of a building administrator or the designee of the superintendent, such officer will notify the building administrator and will make a reasonable attempt to contact the student's parent, guardian, or representative prior to initiating questioning.

Coordination with Law Enforcement

School administrators and/or school security officers shall/may meet periodically with local law enforcement officials to discuss the district's policies and rules regarding law enforcement contacts with the district.

Notification of Investigations Conducted by Law Enforcement Officers

When law enforcement officers initiate an investigation involving questioning of a student on a topic unrelated to a report of child abuse or neglect or to the identity of the student during school hours, the building administrator shall make a reasonable attempt to contact a parent, guardian, or representative of the student(s) prior to such questioning. Notification or attempted notification of a parent, guardian, or representative shall be documented by the administrator involved. If a student's parent, guardian, or representative is not present during such questioning of a student, the principal may be present unless otherwise specified in law or board policy.

Child Abuse and Identity Investigations Conducted by Law Enforcement Officers

The administration shall cooperate with law enforcement officers who are conducting investigations of suspected child abuse or neglect or concerning the student's identity. For any investigations concerning known or suspected child abuse or neglect, school staff shall follow the procedures outlined in board policy GAAD instead of the requirements of this policy.

Law Enforcement Initiated Investigations at School

In cases not involving the investigation of known or suspected child abuse or neglect or involving the student's identity, law enforcement officers shall not be permitted to initiate and conduct investigations involving the questioning of students during school hours unless the student's parent or guardian has given the school permission to allow the questioning, a valid warrant has been presented to the building administrator for such purpose, or in

demonstrated emergency situations. If a demonstrated emergency is found, the building administrator shall require identification of law enforcement officials and reasons for the interrogation or investigation of a student. If the building administrator is not satisfied with either the identification or the reason, the request shall not be granted. The building administrator shall attempt to notify the superintendent and the officer's superiors of the reasons for the refusal.

Taking Students Into Custody

Students shall not be voluntarily released by school officials to law enforcement authorities unless the student has been placed under arrest or taken into custody by law enforcement, school resource officers, campus police officers, or Department for Children and Families ("DCF") authorities pursuant to a child abuse investigation. Except as otherwise specified in this policy, a reasonable effort shall be made to notify the student's parent, guardian, or representative when students are removed from

school for any reason. Parents shall not be notified by school officials when their child is taken into custody by DCF, school resource officers, campus police officers, and/or law enforcement as a result of allegations of abuse or neglect. Except as provided above and/or as specified in a court order or arrest warrant, if a student is taken into custody by a law enforcement officer, school resource officer, or campus police officer, building administrators shall make a good-faith effort to contact the student's parent or guardian. Notification efforts shall be documented.

When a student has been taken into custody or arrested on school premises without prior notification to the building administrator, the school

staff present shall ask the law enforcement officer to notify the building

Disturbance of School Environment

- 5. Any student who has been tried and convicted as an adult of any felony, except theft involving no direct threat to human life.

You are notified that _____, within the past 365 days, has been expelled, adjudged or convicted for an activity listed above.

School District staff are required by both Federal Law and K.S.A. 72-6311 to protect the right of privacy of any student under the age of 18 and the student's family regarding personally identifiable records, files, data, and information directly related to the student and his/her family. The board of education prohibits bullying in any form either by any

student, staff member, or parent towards a student or by a student, staff member,

or parent towards a staff member on or while using school property, in a school

The administration shall propose, and the board shall review and approve

Students who have bullied others in violation of this policy may be

subject to disciplinary action, up to and including suspension and/or expulsion.

USD 320 Bullying Plan

Bullying means: Any intentional gesture or any intentional written, verbal, electronic, or physical act or threat either by any student, staff member, or parent towards a student or by any student, staff member or parent towards a staff member that is sufficiently severe, persistent, or pervasive that it creates an intimidating, threatening, or abusive educational environment that a reasonable person, under the circumstances, knows or should know will have the effect of:

- Harming a student or staff member, whether physically or mentally;
- Damaging a student's or staff member's property:
- Placing a student or staff member in reasonable fear of harm; or
- Placing a student or staff member in reasonable fear of damage to the student's or staff member's property.

Bullying also includes cyberbullying. "Cyberbullying" means bullying by use of any electronic communication device through means including, but not limited to, e-mail, instant messaging, text messages, blogs, mobile phones, pagers, online games, and websites.

Additionally, bullying means any form of intimidation or harassment prohibited by the board of education of the school district in policies concerning bullying adopted pursuant to K.S.A. 72-6147 or subsection (e) of K.S.A. 72-1138, and amendments thereto. USD ___will not tolerate these actions by students, staff, or parents.

For the purposes of this plan and its authorizing policies, "parent" includes a biological, adoptive, or stepparent; guardian; custodian; or other person with authority to act on behalf of a student.

Similarly, a "staff member" means any person employed by the district.

Any act of bullying by either an individual student or group of students towards a student or staff member of the district is prohibited on or while utilizing school property, in a school vehicle, or at school-sponsored activities, programs, and events. This policy applies to students who directly engage in an act of bullying, to students who, by their behavior, support another student's act of bullying, and to all staff members and parents who engage in similar behaviors.

Training concerning identifying, reporting, investigating, and preventing bullying behaviors as outlined in

district policies and this plan shall be provided to students and staff members using district resources

available for such purpose and shall be provided through school assemblies, staff development, or other

appropriate forums at least {annually/biannually}.

The board or the district administration on behalf of the board may seek student, staff, parent, and/or

community input on the adoption, revision, and/or implementation of the board's bullying policies or plan

as directed or approved by the board.

No teacher, administrator, or school district employee shall engage in, permit, or tolerate bullying.

Retaliation against a victim, good faith reporter, or a witness to bullying is prohibited. A student or staff

member who engages in an act of bullying, reprisal, retaliation or false reporting of bullying, shall be

subject to discipline in accordance with school district policy and procedures. The school administration

and/or board may take into account the following factors when determining an appropriate disciplinary

action for such prohibited conduct: the ages of the parties involved; the developmental and maturity

levels, special education needs of the parties involved, and the severity of the behavior.

Discipline guidelines for student bullying may be found in student and employee handbooks. Offenses

over time or single offenses which are severe in nature may result in discipline up to and including

suspension and/or expulsion or termination from employment. Parents participating in prohibited

bullying conduct aimed at district students and/or staff members may jeopardize their access to district

facilities; district property; school sponsored activities, programs, and events; and/or district students

and/or staff members through the district's communication systems. As appropriate, reports to local law
