BOARD OF EDUCATION MEETING MINUTES

Wamego Public Schools August 20, 2018, 7:00 p.m.

1. ROLL CALL (7:00 pm)

President Cory Meyer called the regular meeting of the USD 320 Board of Education to order at 7:00 p.m., Monday, August 18, 2018 at the USD 320 Professional Learning Center. Members of the board present were Bruce Coleman, Ryan Hargitt, Michele Johnson, Cory Meyer, Rob Pettay, and Sheryl Wohler. Nicolette Zeigler was not present.

President Cory Meyer asked for a show of hands and verbal from Nicolette Zeigler on the vote: 4 for Ryan Hargitt; 3 for Bruce Coleman. Majority vote of 4 – Ryan Hargitt voted in as Vice President.
