September Items for the Good
Central Elementary

Kindergarten

We are off to a great start in kindergarten this year! Teachers were able to meet with parents before school started this year to review the Ages and Stages Questionnaire that they completed for their child and have parents share anything they would like with their child's teacher. These conferences were a wonderful way to begin building a great relationship with parents. Below are just some of the awesome things we are doing in these first weeks of school!

- Painting and being creative at art center with our center friends
- Learning the letters and sounds for P and U and putting those sounds together to build the word PUP and doing a directed drawing of a PUP
- Building Mat Man with our Handwriting Without Tears pieces to help us learn to draw a person with major body parts
- Decorating our rules poster to take home to help us learn and practice the importance of rules at home and at school and how they keep us safe and respectful
- Working at puzzle center during center time





First Grade

It has been an amazing start in First Grade! We have spent the first few weeks building relationships with our students and teaching them our routines and expectations. One of our focuses this year will be on teaching our students about the good character traits. These first few weeks, First grade has been working on how to treat others with respect, as well as respecting ourselves.



First grade has also been learning about families and how there are lots of different types of families with different traditions.



Second Grade

Each fall and spring all second graders take the MAPs (Measure of Academic Progress) test for reading and math. This test provides teachers with data about each student and where he or she is in his or her individual learning process. The test is designed to give a more challenging question when a student answers correctly or a simpler question if the answer is incorrect. The math test includes operations and algebraic thinking, numbers and operations, measurement and data, and geometry. The reading test includes phonological awareness, phonics, concepts of print, vocabulary and word structure, comprehension, and writing. Once we get the results, we will go over what areas we are lacking in. In May, we also compare the beginning of the year to the end of the year results to show us where we are improving and where we need to still bump up our instruction. We love the MAPS test because it lets us know where our students are at compared to the rest of the nations children.

Here are some fun facts for you! The percentile is the average for all our students, include ones on math IEP's. I only took out students with more severe disabilities for example, down's syndrome.

Each year we seem to be right around having our average being in the 70th percentile. Which we are pretty excited about. Having the average of our students in the top 30th percentile in the nation is something we are celebrating.

Last fun fact for the day!

40.6% of our second graders scored in the top 10 percentile on Math MAPs last Spring! If we were there to give out fist bumps...we would!

Reading Team

The beginning of school is filled with excitement, meeting new teachers and friends and getting into a school routine both at school and at home. Assessments are also given to find out what skills the students have retained over the summer from their previous year. Some skills need to be reinforced while new skills are being introduced. While your child works hard at school, some things you can do at home to support reading are also very important. Let them hold the book as they read or as you read to them. Allow

them to turn the pages. Invite them to read with you. Point to the words as you are reading to direct their eyes to the printed word. Read the same 2-3 books for a few days so they can absorb the vocabulary. Allow them to choose a book and talk about the books after reading. As the new school year begins, home and school work together to create readers who love to read.

Specialized Areas

Our Specialized team of PE, music, art, library, counseling, and technology teachers have been getting to know our new students and Kindergarteners. This is a challenge at the beginning of the year as Kindergarteners just don't know how school works. We see them learning the routines and procedures of lining up, using the restroom and washing hands, and eating lunch in a specific time period. By the end of the day, when we have the students, they are tired and ready to go home. So our job is to keep them interested and excited about learning. Each of us will write a time or two about our classes this year. This month it is technology.

The second graders are working on the engineering design process of ask, imagine, plan, create, and improve. We are using it to create marble mazes with legos. The mazes were all so unique and fun to complete. Next week we will work in pairs to create a marble run with two baseboards before moving into an animation project. Not only are we learning the design process, but we are learning procedures for working with a teammate.



First graders are using nonstandard and standard measurements. They used a computer in pairs this week to estimate and measure how many railroad tracks it would take to make the length of a train car. Next week they will use a crayon as a nonstandard measurement to measure items in a picture. Then we will move to measuring in inches with a ruler. At the end of the unit, we will use yardsticks to measure each other's height. The measurement skill and working as a team will be used in technology throughout

the year and, of course, in life.

Kindergarteners are focusing on learning procedures in technology class. Last week they worked with playdough learning how to create but also clean up after themselves.



They used legos this week to sort by colors as well as returning items to the starting location. Next week we will continue with procedures and listening to directions while we make a tower with legos. This is also the beginning of the engineering design process where students ask, imagine, plan, create, and improve their work.

Mrs. Flinn also presented to parents and shared results of our Parent Perception Survey given last spring, as well as provided information on important school topics, such as the Kansas College and Career Readiness Standards, KESA, and our 1 to 1 Technology Initiative. They also shared some information on literacy practices at West Elementary, including some of the interventions we provide to struggling readers. - **West Continues to Focus on Social/Emotional Learning with Second Step Curriculum**

We want all children to be as successful as possible at school. Success in school is not just about reading and math. It is also about knowing how to learn and how to get along with others. We will be using the Second Step program in all classrooms at West to teach these critical skills.

The Second Step program teaches skills in the following four areas:

1. Skills for Learning: Students gain skills to help themselves learn, including how to focus their attention, listen carefully, and be assertive when asking for help with schoolwork.
2. Empathy: Students learn to identify and understand their own and others' feelings. Students also learn how to take another's perspective and how to show compassion.
3. Emotion Management: Students learn specific skills for calming down when experiencing strong feelings, such as anxiety or anger.
4. Problem Solving: Students learn a process for solving problems with others in a positive way.

Our students will be learning a lot this year! Throughout the year, parents will receive Home Links that go with several of the Second Step lessons. Home Links are simple, fun activities for families to complete together. They are a great way for parents to understand what their children are learning and for children to show their parents what they have learned. 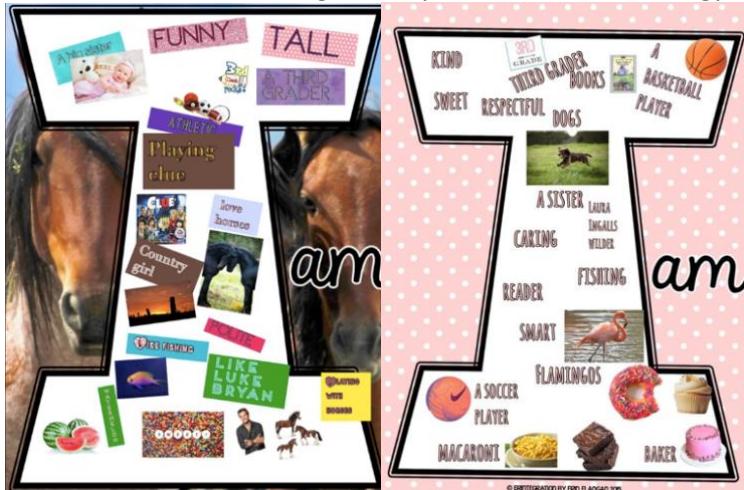
- **Girls on the Run Returning to West Elementary School**

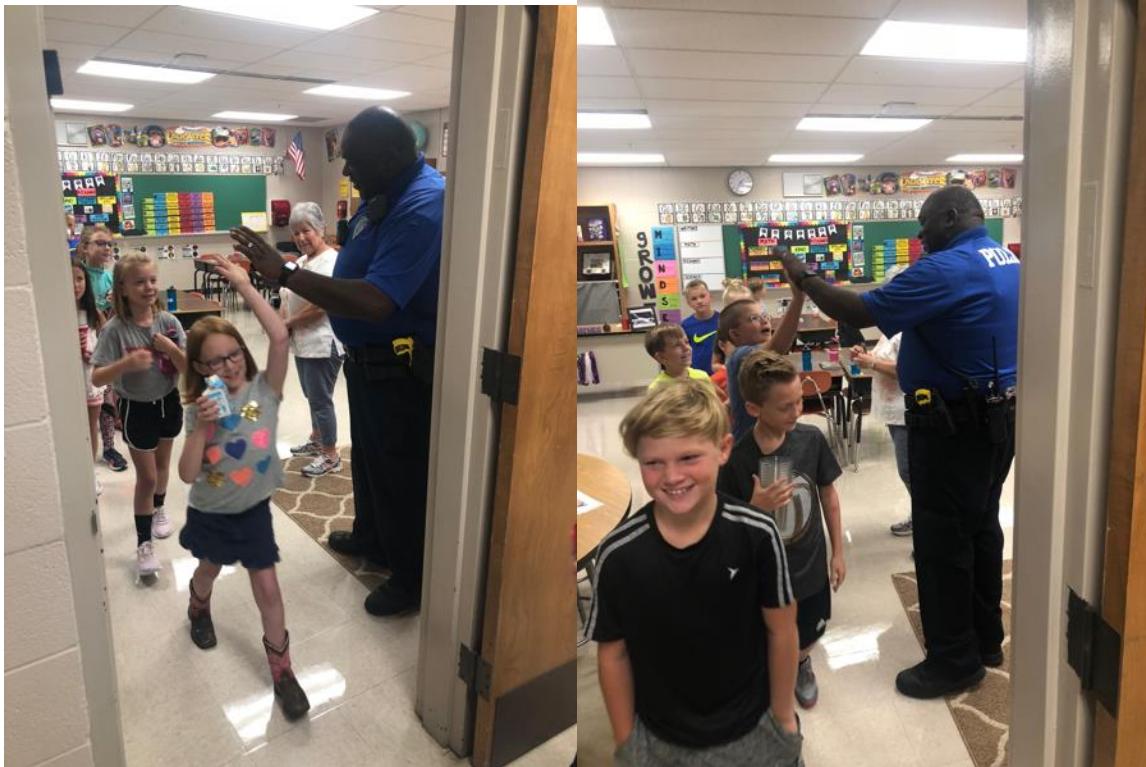
- **Third Graders Learn Building Expectations and Learn More about Classmates**

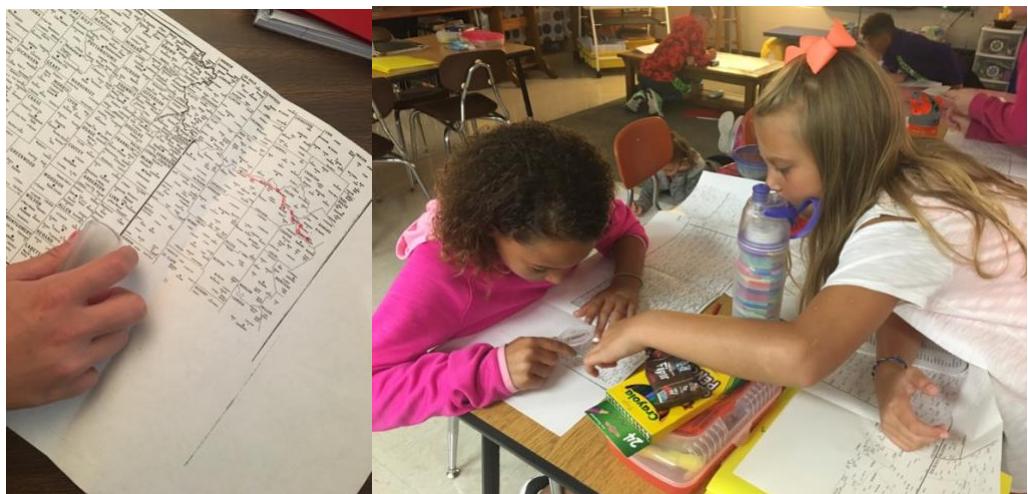
- **Third Graders Meet SRO, Eric Coleman**

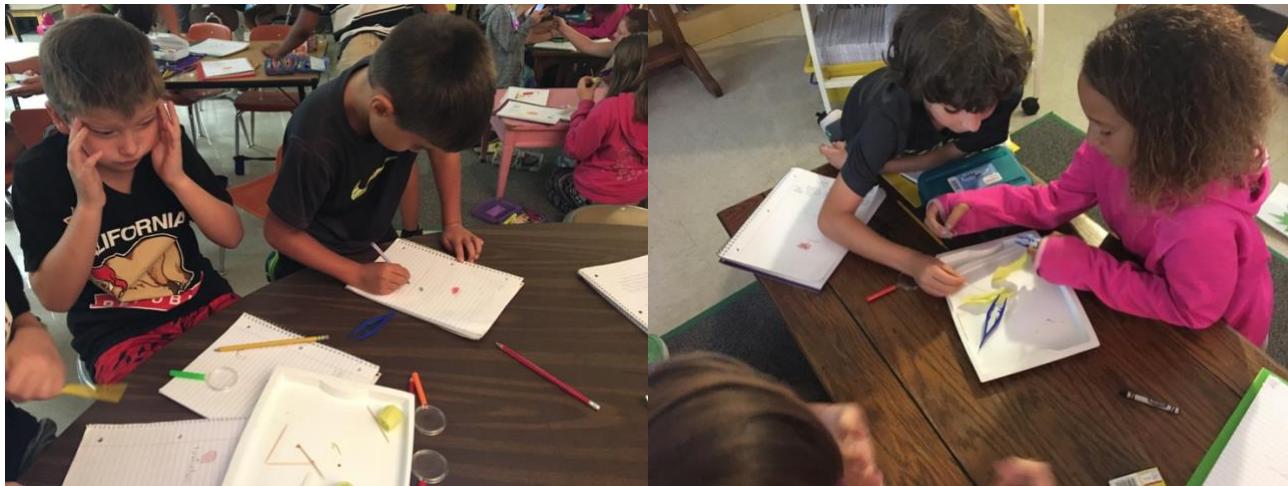
- **Fourth Graders Explore the Trails in Social Studies**

Fourth graders started their social studies unit exploring the Santa Fe Trail. Students have discussed the purpose of the trail, as well as how life was on the trail compared to now. When traveling, pioneers took oxen or mules to pull their covered wagons. Students decided if they were going on the trail if they would take an oxen or mule team. They also mapped the trail. It is a great connection when studying the Santa Fe Trail as much of it goes through Kansas and students are able to make connections to towns they have visited.



- **Fourth Graders Explore Life Science with Dissection of Plants**

Fourth graders dissected fruits, vegetables, and flowers, as they started their life systems unit in science. Students found seeds and parts of plants that are required for growth and reproduction. Students were able to share pictures of their lab dissections on Seesaw to find similarities and differences in the plants. The online Seesaw Journal also allows parents to see the dissections that were done in the classroom.



- **STEM Club for Fifth Grade Begins September 6!**

This year, fifth grade students will have the opportunity to participate in an after-school STEM Club once again. During the club sessions, the students will explore possible STEM careers including chemistry, engineering, coding, design, agriculture and more. This program will allow fifth graders to be exposed to sciences and career fields they may not have encountered yet, therefore opening possibilities that brighten their futures and provide hope for our students and our community. As a culminating activity, we will sponsor a Share Fair where the students are able to share what they have learned with their family and friends. This will be held in the afternoon on the last night of each session. Thank you to Fourth Grade Teacher, Lori Rice, and Fifth Grade Teacher, Natalie Dobie, for providing this opportunity for our students by serving as sponsors and facilitators of STEM Club! We offer both a fall and spring session of STEM Club.

- **Fifth Grade Teacher, Natalie Dobie, Expands Science Knowledge and Pedagogy**

Fifth Grade Teacher, Natalie Dobie, attended a one-week Science Academy at Kansas State University this summer. The primary goal of the institute was to help teachers gain experience teaching inquiry-based science with the help of K-State scientists. They worked with fellow teachers to develop a science unit around corn that addresses the Next Generation Science Standards (NGSS), includes hands-on lab experiments, technology implementation, and uses the scientific method. More importantly, they learned how to teach engineering design using a corn seed. Each fifth grade teacher received lesson resources that will enhance instruction of inquiry-based science. We are proud of Miss Dobie for applying for this opportunity and being selected to participate!

- **Good News Items from West Specialized Team for September 2018**

Our Specialized team has been busy getting students and ourselves used to rules and procedures in our classes. It has been a great start to the year with getting to know you activities along with starting content. Our team of art, library, and technology teachers only see our students once a week, and we have over 700 students each week. Two of our team members, PE and music teachers, see our students about three times per week, and our counselor sees all students once a week while pulling special groups and individuals when needed. Our team is an interesting combination, but we all have the common goal of providing the best education for our students. We will each take a time or two this year to write this 'For the Good' message. This month it will be about technology.

In technology class, the third graders are working on their keyboarding skills. They are using two different programs, Dance Mat Typing and Typing Club, to remember some of their skills from last year. The programs are fun and start with the basics of position and home row. I am quite impressed with how much students remember and how well they are doing at this point. In another week, we will move into the Type to Learn program that tracks our students' progress.

The fourth graders are finding locations on Google Earth. They started with finding their homes and other places in Wamego, then moved to interesting landmarks. They learned how to search, use street view, and the randomizer to locate these spots. Next week they will find sites along the Santa Fe Trail, Oregon Trail, and Pony Express locations since they are studying these places in social studies classes. It is always good to connect with class content whenever we can.

The fifth graders had a choice between keyboarding and coding to start the year. My advisors chose coding. Students get to choose between Scratch 2.0 and Scratch 3.0 which is still in a beta version. I am anxious for students to tell me what isn't working yet in the beta version or what parts they miss from the older version. New students and those not very comfortable with coding are using 2.0. Next week they will choose one of three challenges to code. They will then share their results with their teams.



- **West PTO and Site Council for 2018-2019**

Our first PTO meeting for 2018-2019 school year was held on Thursday, August 9 at West Elementary. This meeting was primarily for planning purposes for the West Fall Carnival scheduled for Friday, September 7. Our regular meetings for this year will be held at 6:00pm at West and we hope to be able to provide childcare again this year. The schedule will be as follows: August 9, September 20, No October Meeting, November 29, No December Meeting, January 17, February 21, No March Meeting, April 11, No May Meeting, and June 4.

West will join Central Elementary for our Site Council meetings this year, which will meet at Central in the library starting at 7:00pm. If you are interested in serving on the Site Council, please contact me. This group serves a very important role in the school improvement process. You will learn so much about what is going on in your child's school and will be supporting our efforts for continuous improvement. Site Council only meets four times during the school year (once per quarter) and will meet on November 8, January 10, February 21, and April 11 (all at Central).

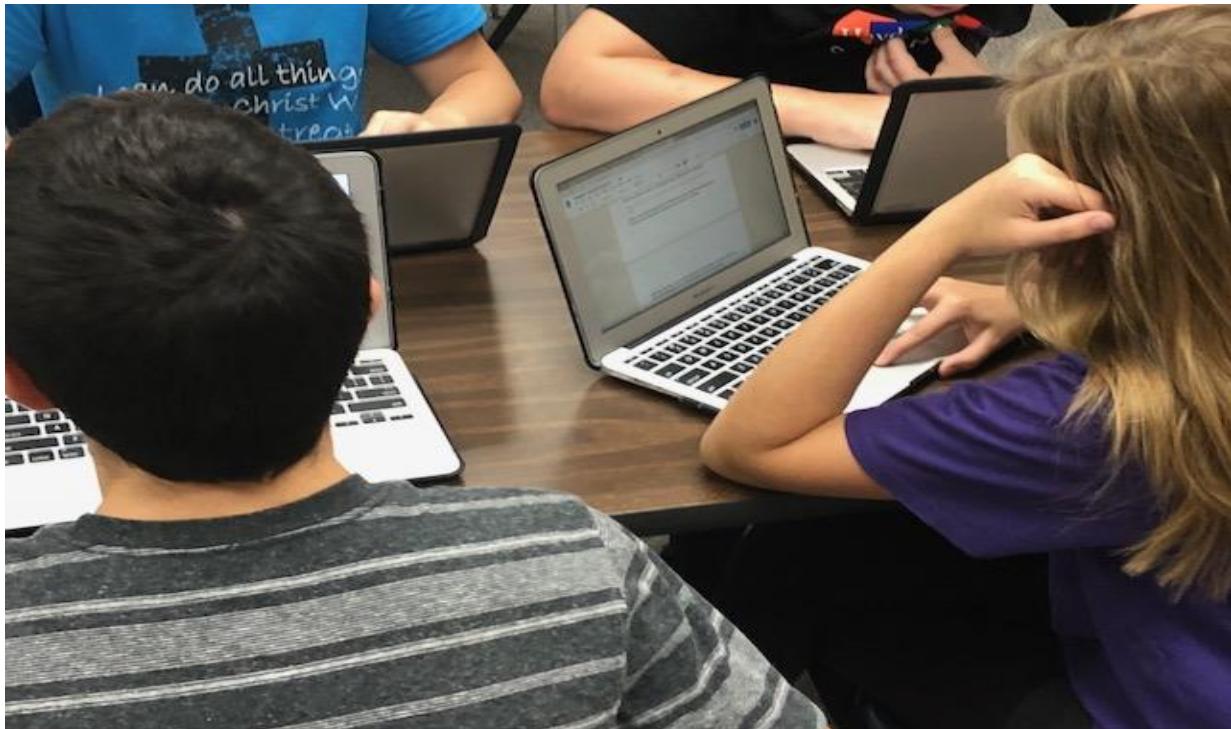

Advisory Lessons

Through dedicated efforts, Social-Emotional Learning Skills are being taught in SIP/Advisory and practiced in classes. Students have taken a survey to assess their proficiency in each of the 4 areas. As as school, making a plan is the weakest area for students. The students are working on writing their own plans and implementing them to increase their chances of success of meeting their goals.

SECD Standards Roadshow

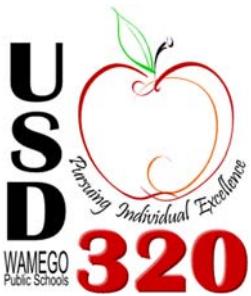

At 9:15 discussion turned to fund raising procedures/policies and accountability. A new procedure and training book for coaches and sponsors was introduced.

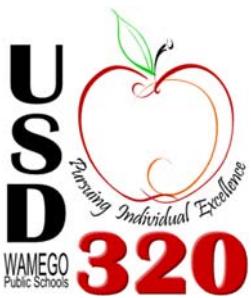
Social media/communications with the public was the next item of discussion. The board expressed the need in the future for a person to be hired to fill that need.

Rob Pettay made a motion to approve the agenda as presented. Ryan Hargitt seconded. Motion carried 7-0.

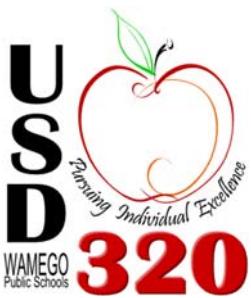
The board began its annual facilities tour with viewing the new wood shop space at the middle school. They further toured Mr. Johnson's new tech class space and the new science wing.
